Considering that coming week will be a truncated one, there is high probability that we could witness trading sessions on low volumes. On the daily chart, we are observing that indices have faced resistance at the downward, sloping trendline joining the two significant highs of 21108 – 20664 / 6338 – 6181 levels, which is the immediate resistance for the indices. Only a close above 19776 / 5930 levels would see an upside momentum. In such a scenario, indices could test 20210 – 20425 / 6052 – 6120 levels. However, a Doji" candlestick formation on the weekly chart clearly indicates indecisiveness prevailing at current levels and, hence, a consolidation or retest of the 200-day SMA, which is at 19031 / 5713 levels, could be expected. Since the daily intermediate trend remains up, it has Fibonacci support at 19303 – 19014 – 18781 / 5791 – 5706 - 5638 levels. We maintain our view that any reversal near the support levels would give good opportunities to trade on the long side.
