#### Diwali crackers

#### Markets today: Support @5650

The Nifty ended with a negative close at 5,698 with a very strong support at 5,650. The index traded volatile between 5,750-5,650 many times but at the end it recovered with good volumes. The market breadth was negative throughout the day with 425 declines and 713 advance with selling pressure around the 5,750 mark. The index has good support at 5,650 and should gain upside momentum once it goes past 5,760. Intra-day momentum indicators have some positive divergences and are near the zero line. The downside momentum has slowed down and 5,650 is the level to watch out for reversals. The index should trade in the range of 5,650-5,850 for some more time before it breaks on either side. The bias remains intact with reversal at 5,650. We expect momentum to be positive and volatile.

Essar oil has gained momentum and is likely to target Rs70. Reliance Capital is looking good till Rs2,200 and a strong support at Rs2,000. IDBI shares looks set to go past Rs170 in couple of sessions.
