

Market Outlook (Medium Term View)

Negative sentiments on the back of a melt down in the early morning session for Asian markets soon trickled down on the Indian session as well with the major indices opening deep in the red. Buying interest at lower levels soon pulled the market from lower levels but sustained negative sentiments in the Asian market had stronger influence on the market sentiments with BSE Sensex closing with a loss of 52 points while Nifty closed down by 14 points. Amongst the broader market indices the benchmark BSE Midcap and Smallcap managed to fair better then their frontline counterpart closing with a loss of less than 0.01 percent. Sentiments reading both for the broader market as well as the frontline Sensex stocks were marginally in the red while Volume numbers for the cash segment saw a small increase with the BSE and NSE combined turnover of Rs.12700cr as against Rs.12100cr on the previous trading session.

On the institutional front Foreign Institutional Investors continued on their buying spree with a net inflow of Rs.640cr as against a net inflow of Rs.648cr on the previous trading session. Sustained buying interest from the FII camp could be considered as a sign sustained underlying buying interest from the long term investors. Domestic Mutual Funds too after a just one day of negative inflow numbers turned positive with a small net inflow of Rs.19cr. Coming back to the outlook for the days session the consistent buying interest witnessed at lower levels in the days session calls for market regaining buying support at lower levels. The positive market trend in the early morning opening session for the Asian market would also help build positive support for the Indian market session. But the week end phenomena would restrain the Bulls from carrying any large positions over the weekend. Volatility expected to be back in the market for awhile. Watch out for volume numbers in the light of turnaround in broader market sentiments reading for clues on the very near term trend.

Corporate News:

Cadila Healthcare Ltd (Zydus Cadila) has acquired 100% stake in Nippon Universal Pharmaceuticals Ltd thereby strengthening its base in Japan.

Hotel Leelaventure Ltd has secured funds of \$100 million (Rs 430 crore) through a foreign currency convertible bonds (FCCBs) issuance. It has the option to increase it by another \$10 million.

Praj Industries will enter into a 60:40 joint venture with Netherlands-based Aker Kvaerner Netherlands BV. It is also looking to acquire a Brazilian company to establish a foothold there. The company is a supplier of cane molasses-based ethanol plants and offers technology for a wide range of feedstock, including cane juice and syrup, beet juice and starch-based raw materials such as grains and tubers. An engineering and construction major, the Netherlands partner offers expertise from concept studies to design, engineering, project management, technology delivery, procurement and maintenance services.

Gemini Communication Ltd has bagged a Rs 57.60-crore order from the Punjab government for supplying hardware and providing installation and maintenance

services on IT infrastructure for phase III of the state's ICT Education project. This project will cover about 2,085 government schools in the rural and urban areas across Punjab. It will be carried forward on an LMT (lease maintain and transfer) basis for five years.

ACC Ltd posted a net profit for the first quarter of the fiscal which rose 54.5 per cent. Net profit for the quarter ended March 31, 2007 was reported at Rs 363.75 crore, up from Rs 235.42 crore in the corresponding previous period. A one-time gain of Rs 19.96 crore from sale of a subsidiary during the quarter also helped boost the bottomline. Net sales at Rs 1,674 crore (Rs 1,342 crore) rose 24.8 per cent.

MRF's net profit for the 2nd quarter ended March increased seven-fold to Rs 35.84 crore compared with Rs 5.84 crore previously. The turnover increased to Rs 1,087 crore from Rs 880 crore in the corresponding period last year.

Biocon posted a consolidated income of Rs 990 crore with 25 per cent growth year on year for fiscal 2006-07. Its net profit of Rs 200 crore was 15 per cent increase year on year. The company has also recommended dividend of Rs 3 per share (60 per cent.)

Economy News:

China's economy grew at a faster-than-forecast 11.1% in the first quarter from a year earlier. Inflation accelerated to 3.3%, the fastest pace in more than two years and breached the central bank's 3% target for the year.
