#### **VIEW POINT: CRUDE SURGE MAY SYNGE STOCKS**

The Sensex rose 640 points Monday as the large caps led by Reliance Energy rallied and took the benchmark over the 19000 hump. It was the third largest rise ever in the history of the markets. The increased levels have also meant that supports and resistance points are now more wider apart than what they used to be at lower levels, giving an impression of increased volatility. This is something the marketmen will have to learn to live with.

The rise in the crude oil prices beyond the \$86 mark and the warning by Citibank on the fourth quarter profits have pulled down stocks in the US and Asia and may do an encore in our markets as well. But to say that a reversal will be in place will be wrong. Prices could drift lower in the morning and would need to be watched for any mid-day recovery.

#### **CRUDE SURGES ON TURKEY MOVE**

Crude surged more than \$86 a barrel for the first time as the Turkish government moved its parliament to seek approval of a cross border offensive. Crude Oil jumped \$2.44 to a record close of \$86.13 a barrel.

Parliament was widely expected to authorize the Cabinet's motion seeking authorization for a military campaign in northern Iraq, and the vote would happen Wednesday.

But government is unlikely to immediately order its troops across the border, possibly to see if the United States and Iraq attempt to crack down on the rebel Kurdistan Workers' Party.

Thee Turks had twice acquired similar authorizations from the parliament in 2003, but did not act on them.

#### ACROSS THE ATLANTIC

U.S. stocks thudded lower Monday, with record oil prices catching negative attention from investors also contending with a warning from Citigroup Inc. that the credit crunch could harm fourth-quarter results of the nation's largest bank

The **Dow Jones Industrial Average** lost 108.28 points, or 0.77%, to 13,984.80, its third finish below the 14,000 level this month. The **S&P 500** dropped 13.09 points, or 0.84%, at 1548.71, and the **Nasdaq Composite** fell 25.63 points, or 0.91%, to 2780.05.

**General Motors** was the main drag on the Dow, tumbling 3.6% for the day. **Citigroup**, **American Express**, and **Verizon** all fell by 2% or more.

Several Internet names combined to sink the tech-heavy Nasdaq. **Google**, **Yahoo!** , **eBay** , and **Amazon.com** each dropped at least 2%.

One of the biggest stories of the day occurred away from stocks, as **oil** prices rose past \$86 a barrel for the first time ever. Crude has already been hovering around its all-time high, and news of tensions between Turkey and Kurdish rebels in northern Iraq has been supporting prices in recent days. Oil jumped \$2.44 to a record close of **\$86.13** a barrel.

Energy stocks such as **Exxon Mobil** and **Chevron** were stronger, while truckers and airlines slumped.

The Amex Oil Index rose 1%, and the Philadelphia Oil Service Sector Index tacked on 0.6%.

The earnings torrent will pick up speed Tuesday, as reports from **Intel**, **IBM**, Yahoo!, and **Johnson & Johnson**, among others, come due.

Away from stocks, the lone report on the economic docket came from the New York **Federal Reserve** Bank, which said its Empire State manufacturing index jumped to 28.8 from 14.7, well above the consensus 13.1.

Elsewhere, Fed Chairman **Ben Bernanke** is due to deliver his economic outlook when he speaks before the Economic Club of New York at 7 p.m. EDT.

Among precious metals, **gold** crept towards a 28-year high as the dollar continued to fall. Gold futures added \$8.30 to **\$762.20** an ounce.
