Support is pegged at Rs.159 while a decisive breach of Rs.151 could test Rs.137. If the supports hold, resistance in rallies is at Rs.185, and Rs.193. **Resistance: 173, 185, 193. Support : 159, 151, 137.** 

## Dishman Pha (321.05)

The daily chart of Dishman Pha shows a bullish candle on high volumes. It is taking support from the trendline in blue pegged at Rs.310. If it holds the support, resistance in rallies is pegged at Rs.332 and Rs.345. A decisive breach of support may test Rs.292.

Resistance: 332, 345, 368. Support : 309, 303, 292.
