VIEW POINT: BEATING AROUND THE 4250 BUSH

The Nifty is likely to beat around the 4250 bush this settlement, give or take 30 points. The support for the Nifty cash is 4216 and the resistance is at 4280. Having braved a week's fall of the US markets, the Nifty is unlikely to fall in line with the western bourses till the June expiry, which happens Thursday. The current calls and puts scenario makes 4300 a very strong resistance and 4200 a support. As these positions have been carefully nurtured over a three-week period, they are unlikely to be given up without a fight.

If the Dow breaks the 13250 mark, then it could trigger a wave of sell orders in other markets also. Till that point of time, our markets can afford to ignore the happenings at other exchanges. The FIIs have turned sellers once again in the Nifty and stock futures and one may expect them to keep the stance at these levels. We could take an intra day dip of around 30 points, but the Nifty June cookie may hold up for the residual portion of its life. Engineering stocks could extend their gains for the settlement.

ACROSS THE ATLANTIC

U.S. stocks finished lower on Monday, with the Dow Jones Industrial Average losing earlier gains of up to 120 points, as jitters resurfaced about the impact of the distressed subprime mortgage market and of higher interest rates on financial firms.

The **Dow Jones Industrial Average** closed with a loss of 8.21 points, or 0.06%, to 13,352.05. The **S&P 500** surrendered 4.82 points, or 0.32%, to 1497.74, and the **Nasdaq** lost 11.88 points, or 0.46%, to 2577.08

In the financial sector, **Bear Stearns** continued to be in focus amid the near-collapse of two of its hedge funds, and its shares fell 3.2%. **Goldman Sachs** slid 2.5%, **Lehman Brothers** lost 2.1%, and **Citigroup** dropped 1.4%.

Dow component **General Motors** climbed 2.3% after Goldman Sachs upgraded the automaker to buy from neutral. The firm said it expects that GM shares should jump due to sizable yields from union talks. GM finished up 81 cents to \$36.27.

Energy prices, which dropped earlier as a strike in Nigeria ended over the weekend, rebounded near the end of the session. **Crude**, which fell as low as \$67.55 earlier, finished higher by 4 cents at **\$69.18** a barrel.

Elsewhere, natural gas lost 19 cents to \$6.94 per million British thermal units. Among precious metals, **gold** was off \$2.30 to **\$654.70** an ounce, and **silver** was down 14 cents to close at **\$12.87**

The first economic data of a busy week came out at 10 a.m. EDT, when the **National Association of Realtors** reported **existing-home sales** for May. Sales were essentially in line with expectations at a 5.99 million annual pace. The rate for April was revised upward to 6.01 million from 5.99 million previously

The report comes a day before the **Commerce Department** is expected to say that **new-home sales** fell 5.7% last month to an annual rate of 925,000 units.

Later this week, the **Federal Reserve** will meet for the fourth time this year. No change in the target fed funds rate is expected, but the language contained in the accompanying statement will be closely scrutinized.
