

Market Outlook (Medium Term View)

The sensex faced selling pressure from the psychological level of 14000. Markets ended the day on a flat note with players adopting a cautious approach ahead of the RBI credit policy. Auto, Banking and Real Estate stocks in particular remained subdued ahead of the policy. Expectations to some extent are of hawkish statements in the policy especially on the inflation front. Also there are expectations that the RBI may bring some curbs on ECBs.

Metals, power stocks continued to see interest. Among the metal pack, Tata Steel, Jindal Steel saw smart gains. PFC, Tata Power, REL, JP Hydro were among the gainers. Software stocks remained subdued with rupee appreciating further.

Among the mid-cap stocks, Syngenta remained locked in upper circuit on expectation of a higher exit price in the delisting offer from parent.

FIIs were net sellers of Rs 142 cr while DIIs were net buyers to the tune of Rs 257 cr as per provisional data. In the futures segment, FIIs were net sellers to the tune of Rs 201 cr.

Vedanta has acquired Mitsui's 51 percent stake in Sesa Goa for a price of Rs 2036 per share. Sesa Goa shares closed at 1740 and thus expect short term upsides. The open offer for 20 percent shares will be made at Rs 2036 per share.

All eyes now are on the RBI credit policy. As indicated earlier, expectations are of hawkish statements though no harsh steps are expected in this policy since RBI has taken steps in advance to counter inflation. Any harsh measures could bring some correction into the market. Any steps which could trigger increase in interest rates could lead to some selling in interest rate sensitive sectors like auto and real estate.

Corporate News:

Siemens has announced that it will acquire a 77 per cent stake in the Chennaibased iMetrex Technologies (ITL) that specialises in providing integrated security, fire safety and building automation solutions.

Star India stands to lose Rs 100 crore following the decision of India's largest advertiser Hindustan Lever (HLL) to pull its advertising off the Star network. Talks were going on between HLL and Star for the past seven weeks to lower ad rates post the conditional access system (CAS) roll out in Mumbai, Delhi and Kolkata since January. HLL was believed to be demanding a 35 per cent discount on the existing ad rates, while Star was not budging beyond 25 per cent, said sources close to the development.

Tata Motors may soon set up a car manufacturing unit in Egypt, North Africa and is said to have held talks with an eight-member high-level delegation from Egypt, which is here on an investment and tourism promotion drive.
