Commentary:

Sensex ended flat on weak domestic cues

Following weak global markets and the assassination of Pakistan's leader Benazir Bhutto, the Sensex opened with a negative gap of 59 points at 20,158. It further slipped into red zone after the government announced that the wholesale price index rose 3.45% for the 12 months ending Dec 15 as compared to 3.65% during previous week. However, the market recovered during late noon to end flat at 20,206.95, losing 9.77 points or 0.05% on the back of buying in consumer durables, realty, and metal sectors.

The Nifty fell 1.80 points or 0.03% to close at 6,079.70.

Market breadth positive

The market breadth was positive on BSE as out of the 2,953 stocks that were traded, 2,270 advanced, 651 declined and 32 remained unchanged, with a healthy advance decline ratio of 3.49.

DLF surged; Wipro slipped

DLF soared 5.35% to Rs. 1,063 on reports that the Company is planning to raise USD 5 bn over the next three years by listing five of its business units, including DLF Homes, DLF Retail, DLF Hotels, DLF Utilities and DLF Infrastructure.

Wipro declined 3.52% to Rs. 529.95 on reports that Capgemini has denied takeover talks with the Company.

Nikkei and Hang Seng fell

The Nikkei 225 slipped 1.7% to close at 15,307.78 after the factory output data slid 1.6% from a month earlier.

The Hang Seng Index declined 1.7% to close at 27,370.60 after Hong Kong's exports grew at the slowest pace in 14 months in November due to reduced shipments to the US.
