# Market Roundup

After opening marginally higher at 13,963, the Sensex slipped to a low of 13,916 in the morning deals. Index, thereafter, displayed a range-bound movement for the major part of the day. Fresh buying towards the close saw the index cross the 14,000-mark, for the third day in a row, to touch a high of 14,003 up 87 points from the day's low. The Sensex finally settled with a marginal gain of 23 points at 13,972. The market breadth was neutral. Out of 2,656 stocks traded, 1,302 moved up, 1,293 slipped and the rest were unchanged. As per the provisional figures released by NSE FIIs were net sellers in cash market to the tune of Rs.1,528.7.

# **Economy Watch**

India and Romania have decided to raise bilateral trade to USD 1 billion in the next couple of years. Trade has witnessed an increase of 69% to around \$450m in 2005 as against previous year. Both countries have set the above target in a meeting with the economic delegation from Romania organized by the confederation of Indian industry (CII). Till now 20 Indian companies have been registered in Romania.
