## Volatile trading

The Nifty ended the trading session on a negative note after witnessing high volatility during the day. In the near term the index is likely to trade amid high volatility and on the upside it could test 3175 and 3200. On the downside there is a support at the 20-DMA at 3090. Below 3090 the next support for the Nifty is at the 10-DMA at 3030. As long as the index stays above 3030 on a closing basis, the bias is positive.

Reliance Industries could test Rs1,010 and it has a support at Rs960. Century Textiles should find support around Rs380 and on the upside it could test Rs415. Ranbaxy has a support at Rs360 and it faces a resistance around Rs390.
