That it is submitted that in compliance to the above said direction Additional Member (Mechanical Engineering), Railway Board was nominated to chair the committee which met on 10.12.2014 wherein the Member Secretary, CPCB, Professor of Environment Engineering IIT Delhi, Senior Executive Director RDSO, Director Refinery from Ministry of Petroleum and General Manager, Group General Managers from RITES among others were present. The minutes of the meeting dated 10.12.2014; the extract of the deliberations and objective sought to be achieved in furtherance of direction is enclosed

and marked herewith and marked as **Annexure:A-2** (Pages-).

- 4. That it is submitted that in furtherance of the objective to the above and for ascertaining the progress the committee met on 22.01.2015 wherein among others it was decided that RDSO would prepare a draft monitoring Protocol for exhaust emission measurement of Indian Railway's Diesel Locomotives which shall be shared with other members of the committee specially with IIT Delhi and CPCB. The minutes of the meeting dated 22.01.2015; the extract of the deliberations and objective sought to be achieved in furtherance of the direction is enclosed and marked herewith and marked as **Annexure:A-3.(Page).**
- 5. That it is submitted that in furtherance of the objective to the above and for ascertaining the progress the committee again met on 13.04.2015 wherein among others it was observed by IIT Delhi and CPCB that the necessary methodology and technical input should be detailed to the expert members by RDSO in the monitoring protocol for exhaust emission measurement of Indian Railway's Diesel Locomotives afterwards which shall be published in booklet form and also with regard to the test car built by RDSO for checking emission standard, data collection thereof for further analysis was discussed in detail among other deliberations with other members of the committee specially with IIT Delhi and CPCB. The minutes of the meeting dated 13.04.2015; the extract of the deliberations and objective sought to be achieved in furtherance of the direction and the booklet of the PROTOCOL is enclosed and marked herewith and marked as Annexure: A-4(Pages-
- 6. That it is submitted that in furtherance of the objective to the direction issued by this Hon'ble Tribunal the committee again met on 21.05.2015 for recording the action taken report on previous deliberations including the working methodology, output of the mobile emission test-car, the present technical know-how for studying feasibility of retro-fitment of emission control systems in existing fleet of approx. 5000 diesel locomotives spread across 16 zones of Indian Railways, the financial implication; solution thereof, the active participation by CPCB,MOEF,IIT, MoPNG were discussed in detail and a road map for making effective steps in furtherance of meeting intent

- of the directions sought to be achieved by was deliberated extensively. The compliance report of the committee dated 21.05.2015; the extract of the deliberations is enclosed and marked herewith and marked as **Annexure: A-5 (Pages**).

That it is most respectfully submitted that the submissions made as above are the conscious deliberation of the committee comprised of high-level technocrats, experts of the subject constituted in terms of the direction issued by this Hon'ble Tribunal and accordingly the answering respondent the Ministry of Railways has top-most priority for contributing in the clean pollution-free environment to the citizen of the country.
