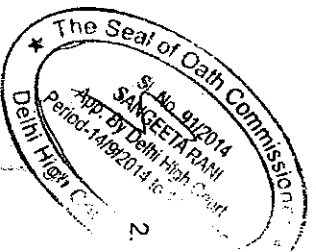
AFFIDAVIT/STATUS REPORT ON BEHALF OF THE RESPONDENT

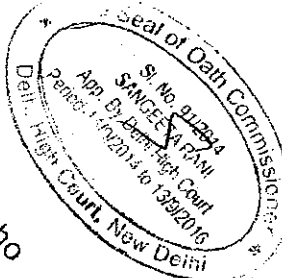


