Appeal u/s 19 of RTI Act submitted by Shri Rejimon CK, 453, Nav Sansad Vihar, Plot No.-4,
Sector-22, Dwarka, New Delhi-110077.

Order

Shri Rejimon CK, has filed an online appeal dated 11.08.2015 mentioning therein that he has not received information w.r.t. his RTI application dated 18.06.15 (DEPOL/R/2015/60206).

On perusal of present appeal with its enclosure, reply of PIO/T-HQ vide no. F. 471/RTI Act/15/2870/RTI Cell/Tr., dated 15.07.2015 and reply & comment of PIO/T-WR vide no. F. 160/RTI Act/15/199/RTI Cell (WR) dated 22.07.15 & F. 160/RTI Act/15/250/RTI Cell (WR) dated 08.09.15, it is observed that PIO/T-HQ transferred the online RTI application of appellant to PIO/T-WR on 22.06.15 as the matter relates to PIO/T-WR. PIO/T-HQ provided the information to appellant w.r.t. his online RTI application dated 18.06.15 on his e-mail ID i.e. rejimonck@gmail.com on 15.07.15. PIO/T-WR also uploaded the information on RTI Online system on 22.07.15 and appellant can view information given to him by PIO/T-WR on RTI Online system. Hence, information has been given to appellant by PIO/T-WR and PIO/T-HQ within stipulated time period mentioned in RTI Act-2005. It is worth mentioning that two same RTI applications in context of present appeal were received in the office of PIO/T-HQ, among them one of RTI application has incorrect seriatim and the other one does not bear serial number. As far as information provided to appellant by both PIOs is concerned, correct and complete information is to be provided on following points:-

1. Please provide list of staff at each point at Sector22/21 T Point, T Point at 210 end deputed and on whose instruction. If any standard instruction given please provide the copies of the same.
2. Please provide have DTP made any provision for NO Halt/No Stop before and after under pass. If not please provide the name and designation.

However information on point i.e. "Have DTP proposed shifting the BUS Shelter just before under pass and after the under under pass while entering to Dwarka If so please provide the copies of the same. In case the same is not taken up, please provide as per form responsible personal with designation to take up with DTC and DTIDC" have been provided by both PIOs but information provided by PIO/T-WR is correct. Besides, collective information provided by both PIOs on remaining points are correct.

Direction:- PIO/T-WR is hereby directed to provide correct and complete information to appellant on point no. 1 (second part) & point no. 2 (if available) as mentioned above within 15 days of receipt of this order.

PIO/T-HQ is hereby directed to transfer the RTI application to PIO/MCD (South) for providing information on last point of RTI application, within 05 days of receipt of this order.

Appellant may meet PIO/T-WR in connection with his RTI application/grievances and/or undersigned in connection with this appeal on any working day during office hours with prior intimation. The appeal is disposed off accordingly.

Let a copy of this order be sent to the appellant. He can file an appeal against this order to the Chief Information Commissioner, August Kranti Bhawan, Bhikaji Cama Place, New Delhi-110066, within 90 days, from the date of receipt of this order, if he so desires.
