Subject: - Regarding supply of information under RTI Act-2005.

Please refer to your **online** RTI application dated 18.06.2015 received in this office on the subject cited above. The information related to this office is as under:-

- Name of the area TI:- Sh. Manoj Kumar Sinha, ACP/T/SW:-Sh.Rajender Prasad and the DCP/T/WR :-Sh. Milind Dumbere (IPS).
- TI Dwarka and respective staffs are responsible for ensuring smooth flow of traffic in front of Sec.21 Metro station Dwarka and TI Kapashera and respective staffs are responsible for ensuring smooth flow of traffic on Dwarka link road. Staffs at traffic junctions are deployed on rotation basis and changed after every two months.
- Entry from Road No. 210 is not prohibited to be merged in Dwarka Link Road. No such written instruction has been given to the staff.
- There is no specific reason for merging the traffic at mouth point of Underpass at sec.21 Dwarka. Land owning agency DDA has to chalk out the plan and construct the roads accordingly.
- In zone Sec. 22/21 Dwarka ASI Vedpal No.2494/T, HC Shukhbir 418/T, Ct Manoj 5739/T and Ct Jitender 5042/T are deployed.
- No such proposal for shifting of bus stops has been sent. However these two places are being monitored by traffic staffs. Proposal for shifting of bus stops will be sent only after locating the suitable place.
- Traffic staff has been deployed at underpass point to regulate the smooth flow of traffic as per the situation.
- Prosecution is done regularly against the violator of traffic rules if anyone is found.
- Various type of road sign boards are placed on roads by the concerned road owning agency and offenders are prosecuted by DTP as per law.
- No proposal for installment of CCTV camera in underpass has been sent.
- DTP write to civic agencies for repairing or repainting i.e. filling of ditches, reconstruction of roads, repainting of Zebra Crossing and other road markings as per the requirement from time to time for ensuring smooth flow of traffic.
- Rest of information as sought by the applicant does not relate to this office. Hence, the same may be had from concerned.

It is also informed that in case you are not satisfied with the above reply you have a right to appeal against this order within 30 days from the receipt of this order. The Appellate Authority is "The Dy. Commissioner of Police, 1st Floor, Traffic Police Headquarters, Todapur, New Delhi".
