We request you to issue a DD NO and assign IO to investigate this matter and File FIR IPC section 304 (causing death by negligence), Section 336 (endangering life and safety of others) and Section 288 (negligent conduct in respect of repairing or pulling down a building or structure)

Allow me to refer to my email below dated 29/4/2015.

Today around 8.15 while I was walking near road No. 225 just 80 mtr away from Sector 23 Police Station found a horrific scene an accident where Senior Citizens and their family had NARROW ESCAPE.

The culprits are DDA Engineers of Dwarka mainly EE, SE, CE, EM. The service road junction between Himalay Apartment and Classic Apartment was dugged up in the middle without any protection or warning. The elderly person who was driving at this blind spot barged into pile of debris and kerb stone placed centre of the road.

Finally some of the evening walkers had to help the family and get the vehicle out.

The pictures and video are self explanatory.

Please file an FIR against the concerned enginners and their hierarchy for Criminal Negligence.
