Some of these titles concern the science and philosophy of ecology and thus are not, strictly speaking, about worldviews as such, although they are of course relevant to the presuppositions, assumptions, beliefs, values, and praxis of environmental and ecological worldviews. Yet other titles concern the ethics, economics, law, and politics that follow (or might follow) from adherence to environmental and ecological norms, values and principles. Finally, a smaller number of titles are histories of ecology or environmentalism (or some aspect or feature thereof), although I've not attempted to include the more regional or localized histories owing to the sheer number of titles. This is a "select" and thus not exhaustive bibliography of books in English. However, and with that in mind, should you know of a title you believe worthy of inclusion that I have missed, please contact me and I'll be happy to consider it for inclusion in the next draft.
