SUBMIT A SOLUTION

After our Constituent Assembly that will take place on 14 November 2017, at COP 23 in Bonn, and once our website is live (Q4 2017), you will be able to submit your solutions by flowing these steps:

SUBMISSION

You can submit your solution via our online platform. It is then eligible to be considered as an Efficient Solution and to be selected as part of our Portfolio of 1000 solutions that will be presented at COP 24. You have one month to complete the submission process.

As part of the submission, you must provide a detailed explanation of your solution. We will not seek sensitive information that might compromise your intellectual property.

APPRAISAL

Your solution will be assessed by independent technical and financial experts according to four criteria: desirability, deployability, sustainability and viability.

All experts sign Non-Disclosure Agreements and you will be able to see which insittuitons we are working with. During the analyses, the analysis, they may engage with you for further clarification.

SELECTION

You will be notified if your solution has met the criteria to be selected as an Efficient Solution and to be part of the Portfolio of 1000 solutions.

Solutions are selected by the World Alliance Team considering the experts' recommendations.
