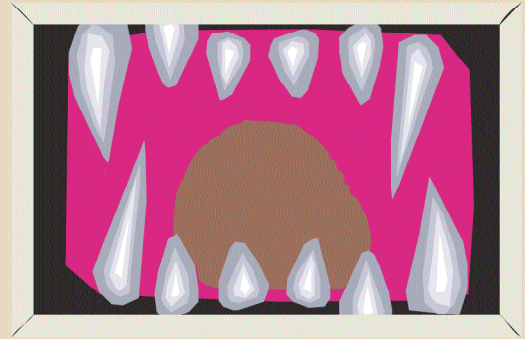

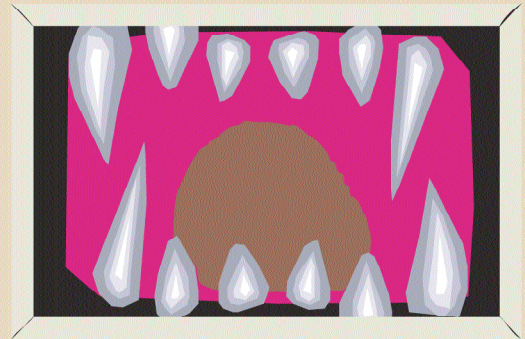

- ✓ Kansas City, MO - KC Election Board members publicly expressed discomfort with the Diebold company—before unanimously voting to purchase Diebold voting systems. Chair Melodie Powell stated, "There have been an enormous number of controversial articles (about Diebold). . . . That really, really concerns me." Joe Serrano, Board Secretary, said, "What will happen if we buy this system (Diebold) and there are problems?" www.kansascity.com
