Nifty made hammer candlestick pattern on daily charts, which shows that bulls are trying to enter from lower levels. On upside, Nifty has resistance at 4625 levels. If Nifty manages to maintain above 4625 levels then some recovery may be continuing else selling pressure may resume.

For Daily Purpose, Trend deciding level is 4625. If Nifty shows strength above 4625 levels, then rally to 4670/4725/4750/4800 may be seen. If Nifty does not show strength above 4625 levels then selling pressure till 4550/4500/4450 may also be seen.

Technical view for the day 20th Dec 2011

On Tuesday, Nifty's opening may depend upon Global clues. On Monday, Nifty made hammer candlestick pattern on daily charts, which shows that bulls are trying to enter from lower levels. On upside, Nifty has resistance at 4625 levels. If Nifty manages to maintain above 4625 levels then some recovery may be continuing else selling pressure may resume. For Daily Purpose, Trend deciding level is 4625. If Nifty shows strength above 4625 levels, then rally to 4670/4725/4750/4800 may be seen. If Nifty does not show strength above 4625 levels then selling pressure till 4550/4500/4450 may also be seen.

Closing summary

Nifty opened negative gap down note at 4626.15 levels and after making initial high at 4623.15 levels, Nifty showed selling pressure and made low at 4555.90 levels, Nifty showed some recovery from day's low but closed in red at 4613.10 levels with 38.50 points loss. Volumes were lower than previous session and market breadth was highly negative with 305 advances, 1187 declines and 44 shares were unchanged. Nifty December future closed with 10.75 points premium at 4623.85 levels. Sensex closed in red at 15379.34 levels with 122.01 points loss.

Tata Motors (up by 4.23%), Cairn (up by 4.13%) and Coal India (up by 2.39%) were major gainers. Axis Bank (down by 6.20%), BHEL (down by 4.28%) and LT (down by 3.69%) were major losers. Buying interest was seen in Oil&Gas and FMCG sectors. Selling pressure was seen in Capital Goods, Banking, Realty and Power sectors.
