Nifty showed selling pressure and went below 4700 important support level. Nifty recovered from lower levels and closed above the 4700 mark. If Nifty sustains above 4700 level in coming sessions, further recovery may be seen.

For Daily Purpose, Trend deciding level is 4730. If Nifty shows strength above 4730 levels, then rally to 4790/4840/4900 may be seen. If Nifty does not show strength above 4730 levels then selling pressure till 4675/4640/4550 may also be seen.

Technical view for the day 24th Nov 2011

On Thursday, Nifty is likely to open on a positive note, however, Global cues shall also have an effect on the trend. On Wednesday, Nifty showed selling pressure and went below 4700 important support level. Nifty recovered from lower levels and closed above the 4700 mark. If Nifty sustains above 4700 level in coming sessions, further recovery may be seen. For Daily Purpose, Trend deciding level is 4730. If Nifty shows strength above 4730 levels, then rally to 4790/4840/4900 may be seen. If Nifty does not show strength above 4730 levels then selling pressure till 4675/4640/4550 may also be seen.

Closing summary

Nifty opened on a negative note at 4779.50 levels, in line with weak global markets. Intraday support was seen at 4730-4640 levels. Once 4730 level was broken heavy selling pressure was seen and Nifty made a low of 4640 level. However, Nifty showed recovery in the last hours and closed above 4700 level. Nifty closed in red at 4706.45 levels with 105.90 points loss. Volumes were higher than previous session and market breadth was negative with 350 advances, 1136 declines and 59 shares were unchanged. Nifty November future closed with 2.55 points disc at 4703.9 levels. Sensex closed in red at 15699.97 levels with 365.45 points loss.

NTPC (up by 1%), Rcom (up by 0.71%) and Bajaj-Auto (up by 0.43%) were major gainers. BPCL (down by 5.34%), JPAssociate (down by 5.13%) and HDFC Bank (down by 4.52%) were major losers. Selling pressure was seen in almost all major sectors.
