

Market Wrap-Up

Clarification on tax residency certificate (TRC) for foreign investors by the Finance Ministry and the after effect of the Union Budget 2014 that may be said to be more or less balanced, curtailed the losses on the last day of the week marking gains of close to half a percent. Nifty ended the day above the 5700 mark at 5719.70 with gains of 26.65 points and the Sensex added 56.98 points that parked the index at 18918.52. Broader indices however underperformed the benchmarks ending assorted with the midcap index marking gains of 0.29% while the Smallcap index ended in the negative terrain.

Domestic Update

- The finance ministry said it will not question the validity of tax residency certificates (TRCs) held by foreign investors, while noting the current double-tax treaty with Mauritius remains in effect. The clarification from the ministry came after the government created confusion with a proposal stating a tax residency certificate "shall be necessary but not a sufficient condition" to take advantage of double taxation avoidance agreements.
- Indian factories stepped up production last month as domestic orders poured in at a faster pace than January, but weak global demand dented export growth. The HSBC Markit manufacturing Purchasing Managers' Index (PMI) rose to 54.2 in February after falling to 53.2 in January.

Corporate Update

- Mahindra & Mahindra Ltd. has posted 11 per cent growth in its auto sales numbers at 47,824 units in February 2013, as against 43,087 units sold in February 2012. The passenger vehicles segment, which includes UVs and Verito, registered a growth of 14 per cent in sales at 23,421 units in February this year, as compared to 20,537 units in the year-ago period.
- Maruti Suzuki India reported 7.89% decline in its total sales at 1,09,567 units in February 2013. The company had sold 1,18,949 units in the corresponding month last year. In February this year, MSI had recorded domestic sales of 97,955 units compared to 1,07,653 units in the year-ago period, registering a fall of 9.01 percent.
- TCS agreed to pay USD 29.75 million to settle a class-action law suit in the United States, brought by two former non-US-citizen employees.
- TVS Motor Company recorded a marginal dip in total sales at1,65,696 units in February 2013. The Chennai-based auto major had sold 1,72,061 units in February 2012. Two wheeler sales declined in February 2013 to 1,60,895 units from 1,68,996 units in the same month last year.
- Karnataka Bank has revised its interest rate on deposits by 25 basis points (bps) on all fresh retail term deposits with 1-2 years maturity period with effect from March 01, 2013. Accordingly, the rate of interest on deposits will now increase from current 9% per annum to 9.25% per annum.
- With a view to adjust its interest rates in line with prevailing market rates,
 Punjab National Bank has revised the rate of interest on single domestic term deposit of less than Rs 1 crore. Accordingly, with effect from March 01, 2013, the rate has been aligned from 7.50 per cent to 8.75 per cent for maturity period of 180 days to less than one year.
- Jayalalithaa has extended her support to the local farmers against a row over a gas pipeline project of GAIL India Ltd.
- JSW Energy Ltd, the specialized Manufacturer and supplier of steel products, said that its unit VII of 135 MW of the 8X135MW power project at Barmer, Rajasthan has successfully commissioned and achieved commercial operation date.
- Info Edge which owns job portal Naukri.Com, said it has acquired software developer MakeSense Technologies for Rs 8 crore.
