For Daily Purpose, Trend deciding level is 5075. If Nifty shows strength above 5075 levels, then rally to 5150/5200/5250 may be seen. If Nifty does not show strength above 5075 levels then profit booking till 5040/5000/4950 may also be seen.

On Friday, Nifty may open on flat note. On Thursday, Nifty showed selling pressure from resistance near 5150 levels and closed in red. Bears are trying to enter from 5150-5250 resistance zone. Nifty may trade in 4950-5200 range for nest few days and volatility in this zone may be seen. Traders should be cautious. For Daily Purpose, Trend deciding level is 5075. If Nifty shows strength above 5075 levels, then rally to 5150/5200/5250 may be seen. If Nifty does not show strength above 5075 levels then profit booking till 5040/5000/4950 may also be seen.

Closing summary

Nifty opened on positive gap up note at 5130.80 levels and after making initial high at 5136.95 levels, Nifty showed selling pressure and made low at 5067.65 levels. Nifty closed in red at 5077.85 levels with 21.55 points loss. Volumes were higher than previous session and market breadth was negative with 674 advances, 767 declines and 78 shares were unchanged. Nifty October future closed with 3.80 points disc at 5074.05 levels. Sensex closed in red at 16883.90 levels with 74.47 points loss.

ICICI Bank (up by 2.24%), Hcl Tech (up by 2.10%), and TataSteel (up by 1.81%) were major gainers. Jindal Steel (down by 4.77%), Hindalco (down by 3.35%) and TataMotors (down by 3.18%) were major losers. Buying interest was seen in Banking and IT sectors. Selling pressure was seen in Auto, Capital Goods and Metal sectors.
