Technical View: Cash Market

Nifty showed selling pressure from resistance near 4875 level. However, Bulls also protected 4800 levels. Selling pressure may be seen below 4790 levels and on the other hand Nifty may face resistance near 4900 level.

For Daily Purpose, Trend deciding level is 4800. If Nifty shows strength above 4800 levels, then rally to 4860/4900/4950 may be seen. If Nifty does not show strength above 4800 levels then selling pressure till 4750/4700/4650 may also be seen.

Technical view for the day 30th Nov 2011

On Wednesday, Nifty may open on flat note. On Tuesday, Nifty showed selling pressure from resistance near 4875 level. However, Bulls also protected 4800 levels. Selling pressure may be seen below 4790 levels and on the other hand Nifty may face resistance near 4900 levels. For Daily Purpose, Trend deciding level is 4800. If Nifty shows strength above 4800 levels, then rally to 4860/4900/4950 may be seen. If Nifty does not show strength above 4800 levels then selling pressure till 4750/4700/4650 may also be seen.

Closing summary

Nifty opened at 4864.20 levels and after making high at 4866.10 levels, Nifty showed selling pressure and made low at 4787.10 levels. Nifty closed in red at 4805.10 levels with 46.20 points loss. Volumes were at par with previous session but market breadth was negative with 584 advances, 878 declines and 68 shares were unchanged. Nifty December future closed with 11.65 points premium at 4816.75 levels. Sensex closed in red at 16008.34 levels with 158.79 points loss.

Dr Reddy (up by 2.71%), Bajaj Auto (up by 2.29%) and M&M (up by 1.80%) were major gainers. PNB (down by 4.24%) and JindalSteel (down by 3.89%) were major losers. Selling pressure was seen in majority of sectors and majority of sectors closed in red. Realty and Banking sectors were major losers. Auto sector closed on flat note. Some buying interest was seen in Healthcare and FMCG sectors.
