The S&P CNX Nifty closed the day positive up 44.70 (0.77%) points at 5863.30 from 5818.60 Wednesday, on back of low volume. Major loser in S&P CNX Nifty were Jindal Steel & Power (-2.20%), Hindustan Unilever (-1.66%) and Coal India (1.26%) whereas major gainers were Hero Motocorp (+4.04%), DLF (+3.39%) and Asian Paints (+2.74%).

The volume in the cash market for both NSE and BSE put together was down 9.00% to Rs. 120.50 bn from Rs. 131.50 bn Wednesday. The advance/decline ratio stood at 1.28:1 from 2.19:1 for stocks traded on NSE.

The S&P CNX Nifty on the hourly chart opened negative on account of global cues and bounced back on account of short covering during the day end on low volumes. The Nifty on the hourly chart continue to form hidden negative divergence with prices moving up slower as compared to RSI(14). We expect market to test 5885 - 5890 on the upper side before facing any major resistance.

The S&P CNX Nifty on the daily chart faced resistance from downward sloping trend line and closed below it. The RSI(14) on the daily chart also faced resistance at 50 levels and closed just below it.
