For Daily Purpose, Trend deciding level is 5100. If Nifty shows strength above 5100 levels, then rally to 5160/5240/5300 may be seen. If Nifty does not show strength above 5100 levels then profit booking till 5065/5035/5000/4950 may also be seen.

On Friday, Nifty's opening may depend upon Global clues. On Thursday, Nifty showed gap down opening, but also showed good recovery from lower levels. In short term, Nifty is trading in 5000-5160 range and until Nifty manages to sustain above 5160 levels or below 5000 levels, volatility may be continuing. Traders should be cautious. For Daily Purpose, Trend deciding level is 5100. If Nifty shows strength above 5100 levels, then rally to 5160/5240/5300 may be seen. If Nifty does not show strength above 5100 levels then profit booking till 5065/5035/5000/4950 may also be seen.

Closing summary

Nifty opened on negative gap down note at 5086.55 levels and after making initial low at 5033.95 levels, Nifty showed good recovery and made high at 5099. However, Nifty closed in red at 5091.90 levels with 47.25 points loss. Volumes were lower than previous session and market breadth was negative with 517 advances, 929 declines and 66 shares were unchanged. Nifty October future closed with 10.95 points disc at 5102.85 levels. Sensex closed in red at 16936.89 levels with 148.45 points loss.

INFY (up by 2.23%), Tata Steel (up by 2.20%), and Jindal Steel (up by 2.09%) were major gainers. HDFC (down by 4.17%) and Jpassociate (down by 3.63%) were major losers. Selling pressure was seen in Realty, Auto, CD and Power sectors were major losers. Some buying interest was seen in IT and Tech sectors.
