Technical View: Cash Market

Nifty showed selling pressure from resistance near 4800 levels, however, Nifty also showed some recovery from lower levels. Buying interest may be seen if Nifty maintains above 4800 levels else selling pressure may be continuing. Nifty Dec Future expiry due within two days, therefore volatility may be seen and traders should be cautious.

For Daily Purpose, Trend deciding level is 4750. If Nifty shows strength above 4750 levels, then rally to 4800/4840/4900 may be seen. If Nifty does not show strength above 4750 levels then selling pressure till 4700/4670/4620 may also be seen.

Technical view for the day 28th Dec 2011

On Wednesday, Nifty may is likely to open on flat to positive note. On Tuesday, Nifty showed selling pressure from resistance near 4800 levels, however, Nifty also showed some recovery from lower levels. Buying interest may be seen if Nifty maintains above 4800 levels else selling pressure may be continuing. Nifty Dec Future expiry due within two days, therefore volatility may be seen and traders should be cautious. For Daily purpose, Trend deciding level is 4750. If Nifty shows strength above 4750 levels, then rally to 4800/4840/4900 may be seen. If Nifty does not show strength above 4750 levels then selling pressure till 4700/4670/4620 may also be seen.

Closing summary

Nifty opened at 4780.20 levels and after making high at 4800.50 levels, Nifty showed selling pressure and made low at 4723.65 levels. Nifty closed in red at 4750.50 levels with 28.50 points loss. Volumes were at par with previous session but market breadth was negative with 593 advances, 862 declines and 70 shares were unchanged. Nifty December future closed with 0.40 points premium at 4750.90 levels. Sensex closed in red at 15873.95 levels with 96.80 points gains.

RCom (up by 4.60%), Ranbaxy (up by 2.72%) and Tata Power (up by 2.60%) were major gainers. IDFC (down by 3.25%), Axis Bank (down by 3%) and DLF (down by 2.75%) were major losers. Selling pressure was seen in majority of sectors and majority of sectors closed in red. Realty, Metal and Banking sectors were major losers. FMCG and Consumer Durable sectors closed on flat note.
