HIGHLIGHTS

- ⇒ Nifty fell sharply by 143 points on Tuesday and tested an intra-day low of 5542. The index is now heading towards the extremely strong support zone of 5400-5470 and we expect the index to give a pull back rally up to 5800 in the medium term
- ⇒ 80 stock futures saw long unwinding while fresh short build up took place in 47 stocks. Only 5 stocks saw long build up while 9 witnessed short covering
- ⇒ Nifty Call options of strike 5600 had a huge build up of 46,652 lots while Put options of strike 5500 had a build up of 38,419 lots. Put options of strike 5200 also added 37558 lots to open interest
- ⇒ Nifty Put Call ratio (OI) fell to 0.95 with the total open interest in Call options at 1,341,170 lots and that in Put options at 1,277,178 lots
- ⇒ Dena Bank, Crompton Greaves, Reliance Power, BPCL and Idea Cellular appear strong while Tata Power, Titan Industries and Arvind Ltd are likely to remain weak
- \Rightarrow Volatility Index rose sharply by 9.28% from 20.80 to 22.73





STOCK FUTURES - NIFTY STOCKS






OPTIONS OPEN INTEREST CONCENTRATION






