### ORDER:

In the G.O.'s first and second read above, Government have sanctioned the new scheme "NTR Vidyonnathi" for providing professional guidance for civil services examination for SC/ST students and issued guidelines, mode of selection and other details of the scheme. The scheme will come into operation during 2015-16.

- 2. As per the guidelines issued under the scheme, Departments of Social Welfare and Tribal Welfare will invite Expression of Interest from Competent coaching Institutions with an excellent track record for imparting coaching for the above programmes. A Selection Committee constituted for the purpose will short list the institutions and will recommend to Government for empanelment in order to sponsor the students for coaching.
- 3. Government, after careful examination of the matter, have decided to have a single committee to the Departments of Social Welfare and Tribal Welfare to ensure equity among the two Departments and for easy disposal and hereby constitute a Common Selection Committee with the following members:-
  - 1. Principal Secretary to Government, Social Welfare ......Chairman
  - 2. Principal Secretary to Government, Tribal Welfare ......Member
  - 3. Commissioner / Director of Social Welfare......Member-Convenor
  - 4. Commissioner / Director of Tribal Welfare......Member
  - 5. Commissioner, Collegiate Education ......Member
  - 6. Commissioner, Technical Education ......Member
  - 7. Representative nominated by the Finance Department......Member
- 4. The Director of Social Welfare, AP, Hyderabad is requested to take action accordingly.
