The attention of all the Regional Joint Directors of School Education and Dist. Educational Officers is invited to the orders issued in the Government Order cited, a copy of which is enclosed herewith for ready reference.


In the said orders, Government while accepting the recommendation to include VIII Class in the Upper Primary School where the strength in VI and VII classes is 40 and more and where there is no other Upper Primary School or High School functioning within a distance of 3 K.Ms to the proposed Upper Primary School from the academic year 2012 – 13, issued, among others, the following direction:-

“The Commissioner and Director of School Education, Andhra Pradesh., Hyderabad, is requested to take necessary action for inclusion of VIII Class in the Upper Primary Schools by obtaining the proposals from the Districts on viability in enrollment and certification that there is no Upper Primary and High School within a distance of 3 Kilometers from the proposed Upper Primary Schools.”

Accordingly, all the Dist. Educational Officers are instructed to submit proposals for inclusion of VIII Class in the Upper Primary Schools where the strength in VI and VII Classes is 40 and above, together with a certificate that there is no other Upper Primary School or High School functioning within a distance of 3 K.Ms to the proposed Upper Primary Schools, duly signed by the Headmaster, Mandal Educational Officer and Dy. Educational Officer concerned, along with other details of the school through their Regional Joint Director of School Education. The format prescribed for this certificate is also enclosed herewith.

All the Regional Joint Directors of School Education are requested to obtain the above proposals, scrutinise the same and attend a review meeting on **14-08-2012 at 10.30A.M.** convened for this purpose by the Commissioner and Director of School Education at Conference Hall of O/o. C & DSE along with the proposals in complete shape.
