- (ii) To release the grants to school complex timely to utilize properly.
- (iii) To monitor on utilization of grants properly.

Therefore the District Educational Officers, the Project Officers of RVM (SSA) in the state are requested to take necessary action immediately and send a compliance report in the proforma enclosed on unspent TLM Grant balances and release of grant to school complexes for the year 2013 – 14 vide reference 3rd cited above.
