All the Project Officers of RVM(SSA) in the state are aware that guidelines were issued vide reference 1st cited for procurement of Games and Sports material to all Upper Primary schools under Government and Local body managements in the state from SETWIN as it was identified as nodal agency by the Government.

They are also aware that the purchase orders placed with SETWIN Hyderabad for supply of Games and Sports material to all Upper Primary Schools are kept in abeyance vide reference 2nd cited as the procurement should be made by the School Management Committees concerned as per the norms of Government of India.

Vide reference 3rd cited, all the Project Officers of RVM(SSA) were requested to give instructions to the Head Masters of all the Upper Primary Schools in their concerned districts to place order on SETWIN for procurement of required material duly meeting funds from 50% School Grant released in 2011-12 for procurement of Sports and Games material in a decentralized manner by School Management Committees as per the requirement and not through centralized.

But it has come to the notice of the State Project Director that the procurement Games and Sports material is being done through centralized process at district level in Srikakulam and Vizianagaram and therefore they are instructed to submit their explanation for not following the guidelines issued form State Project Office immediately.

In this connection all the Project Officers of RVM(SSA) are informed to follow the guidelines strictly as shown below.

- School Management Committee only shall procure the Games and Sports material only if they require
- No district level centralization shall be done for procurement of the material
- The quality of the material also shall be verified by the School Management Committee only
- If any school does not require Games and Sports material from the 50%
 of the School Grant which was set apart during 2011-12, they should
 utilize the above amount for maintenance of toilets, minor repairs or
 any other activity for the development of school.

The Project Officers of RVM (SSA) are requested to follow the above guidelines scrupulously.
