O R D E R:

The Tribal Welfare Department has stated that the Commissioner of Tribal Welfare, Hyderabad in the reference 7<sup>th</sup> read above has reported that Government have sanctioned (143) Post Matric College Hostels for ST students in the State during 1994-2006 in the G.Os 1<sup>st</sup> to 4<sup>th</sup> read above and subsequently sanctioned (126) Post Matric College Hostels for ST students in the G.O. 5<sup>th</sup> read above while informing that the orders sanctioning necessary staff will be issued separately.

2. In the G.O.6<sup>th</sup> read above, Government have accorded sanction for creation of (126) posts of Hostel Welfare Officer, Gr.II for (126) Postmatric College Hostels, but no class IV staff have been sanctioned.

3. The Tribal Welfare Department has stated that, there is a dire necessity for sanctioning of these posts for the Postmatric College Hostels to make them function smoothly. As a result of non-sanctioning of the posts, the students have to meet the costs from out of their mess charges their by affecting their diet and other related expenditure.

4. Therefore, the Tribal Welfare Department has requested for sanction of the following posts:

- a) Sanctioning (143) Posts of HWO, Grade-II and (715) class-IV staff @ 5 per hostel for the (143) hostels opened in Phase-I.
- b) Sanctioning (630) posts of class-IV staff @ 5 per hostels for the (126) hostels sanctioned under Phase-II.

5. The Government after careful examination of the matter, hereby accord sanction for creation of following posts to the Postmatric College Hostels located in Scheduled Areas:
