Copies of the Government Memos read above, along with annexures are here with communicated to all the District Educational Officers in the state for taking necessary action in the matter.

Further the following instructions are issued, for strict compliance.

- 1. All the District Educational Officers in the State are instructed to effect the Inter District Transfers on spouse grounds and Mutual grounds only.
- All the District Educational Officers are requested to relieve all the teachers who
 are transferred on 22.04.2013.
- The teachers relieved on 22.04.2013 from their District should report to the District Educational Officer of the District to which the Transfer is ordered / sought for on 23.04.2013.
- The District Educational officer should conduct the counseling for postings of the teachers transferred in the Inter District Transfers on 23.04.2013 and posting orders should be issued immediately after counseling.
- 5. The postings should be given by following the counseling process only.
- Counseling should be conducted to the teachers transferred on spouse grounds first and then to the teachers transferred under Mutual grounds based on seniority.
- 7. Posting orders shall be issued against clear vacancies only.
- The teachers who were already promoted to the higher post in the meanwhile in their respective district, their transfer should be effected in the promoted category only and they should take last rank in the new unit.
- The transfer shall be effected to the same management ie. Government to Government / Local Body to Local Body in each category by taking the initial appointment.
- 10. The District Educational Officer should assess the need and necessity of the post in the School in terms of Right to Education Act provisions, as per G.O.Ms.No.55, Edn., dated 23.04.2011 and as per the latest DISE data
- 11. Posting should be given where the enrolment is more and teachers are less as per subject need.
- 12. On receipt of posting orders, the teachers should report to the Headmaster of the School on the same day i.e. 23.04.2013. In case of Headmaster they should report to the Deputy Educational Officer concerned on the same day.
- 13. After completion of the above exercise, the District Education Officer should submit a compliance report duly indicating the place of posting of the teacher, strength in the school and the cadre strength of teachers immediately.
- 14. In respect of the transfers of Headmasters Gr-II , the Regional Joint Directors of School Education shall monitor the place of posting etc., and overall supervision of the entire process.

In the reference 1st cited, Government have issued schedule for inter district transfer of all categories of teachers on spouse / mutual grounds by inviting applications through online duly framing certain guidelines.

- 2. In the reference 2nd cited, the C & DSE, AP, Hyderabad has furnished proposals for transfer of teachers on mutual grounds.
- 3. Government after careful examination of the proposal, hereby permit the Commissioner & Director of School Education, AP, Hyderabad to effect the 716 transfers of teachers on mutual grounds as per para 5 (2) (d) of Presidential Order as indicated in the list annexed as Annexure-I, in relaxation of ban orders on transfer of employees, subject to condition that, it must be ensured the correctness of full information on all the points specified in the revised Format appended to Circular Memo.No.7232/MC-I/2011-1, GA (MC-I) Dept., dated: 04.08.2011, duly deleting the names of those teachers who have withdrawn their willingness for mutual transfer subsequently and their counter parts given in the list annexed as Annexure II to this order.
- 4. Further the following conditions may be followed scrupulously.
 - 1. Posting orders shall be issued against clear vacancies only under respective posts.
 - The teachers will be relieved from the present station by the respective DEO on or before 22.04.2013 and shall report before respective District Educational Officer on 23.04.2013.
 - The teachers who have already promoted to the higher post in the meanwhile in their respective district, their transfer should be effected in the promoted category only and they should take last rank in the new unit.
 - 4. The teachers shall be transferred to the same management ie., Government to Government / local body to local body under each category and in the same category of the post.
 - 5. The postings shall be done by following counseling process only.
 - 6. The candidates transferred shall take last rank in the new unit to which the transfer is effected and also forego seniority in the local cadre from which transfer is effected and an undertaking should be obtained by the DEO concerned to that effect from the candidate and recorded in the SR.
 - 7. The candidate shall not be eligible for TTA / DA and joining time as the transfer are effected at their request.
 - 8. The above transfers effected are however, subject to final outcome of the SLP pending in the Hon'ble Supreme Court of India and other cases, pending if any before Hon'ble High Court of Andhra Pradesh, Hyderabad and Hon'ble APAT, Hyderabad.

- The Commissioner & Director of School Education, AP, Hyderabad is also requested to take further necessary action.

In the reference $1^{\rm st}$ cited, Government have issued schedule for inter district transfer of all categories of teachers on spouse / mutual grounds by inviting applications through online duly framing certain guidelines.

- 2. In the reference 2nd cited, the C & DSE, AP, Hyderabad has furnished proposals for transfer of 611 teachers on spouse grounds.
- 3. Government after careful examination of the proposal, hereby permit the Commissioner & Director of School Education, AP, Hyderabad to effect the 534 transfers of teachers on spouse grounds as per para 5 (2) (C) of Presidential Order as indicated in the list annexed as Annexure-I, in relaxation of ban orders on transfer of employees, subject to condition that, it must be ensured the correctness of full information on all the points specified in the revised Format appended to Circular Memo.No.7232/MC-I/2011-1, GA (MC-I) Dept., dated: 04.08.2011 and ensuring that the percentage of non locals shall not exceed 15% or existing percentage under each category of posts and overall percentage in the district.
- Further the following conditions may be followed scrupulously.
 - Posting orders shall be issued against clear vacancies only under respective posts.
 - 2. The teachers will be relieved from the present station by the respective District Educational Officer on or before 22.04.2013 and shall report before respective District Educational Officer on 23.04.2013.
 - The teachers who were already promoted to the higher post in the meanwhile in their respective district, their transfer should be effected in the promoted category only and they should take last rank in the new unit.
 - 4. The teachers shall be transferred to the same management ie., Government to Government / local body to local body under each category.
 - 5. The postings shall be done by following counseling process only.
 - 6. The candidates transferred shall take last rank in the new unit to which the transfer is effected and also forego seniority in the local cadre from which transfer is effected and an undertaking should be obtained by the DEO concerned to that effect from the candidate and recorded in the SR.
 - 7. The candidate shall not be eligible for TTA / DA and joining time as the transfers are effected at their request.
 - 8. The above transfers effected are however, subject to final outcome of the SLP pending in the Hon'ble Supreme Court of India and other cases, pending if any before Hon'ble High Court of Andhra Pradesh, Hyderabad and Hon'ble APAT, Hyderabad.
 - 9. With regard to the transfers of teachers of Adilabad District, orders will be issued separately.

The Commissioner & Director of School Education, AP, Hyderabad is also requested to take further necessary action.
