ORDER:

In the reference first read above, Government of India have informed that the Ministry of Finance concurred for the revision of cooking cost @ 7.5% annually during the 11th Plan w.e.f. 2010-11 and the scheme is proposed to be continued on existing basis during 12th Plan also.

- 2. In the reference third read above, the Commissioner & Director of School Education, Andhra Pradesh, Hyderabad, has submitted proposal as per the guidelines of Government of India to enhance existing cooking costs @ 7.5% during 2012-13 with effect from 01.04.2012, to revise the cooking cost rates from Rs.3.84 to Rs.4.00 for primary classes, from Rs.4.40 to Rs.4.65 for Upper Primary Classes, as per Government of India norms. The Commissioner and Director of School Education, Andhra Pradesh, Hyderabad, has also requested to enhance cooking cost rates, for providing MDM, from Rs.4.40 to Rs.4.65 for the students in classes IX and X with effect from 01.04.2012 as the State Government has to bear the entire share for these two classes.
- 3. Government after careful examination of the matter, hereby order for implementing the Central share for revised Cooking cost under Mid Day Meal Scheme in Primary and Upper Primary Schools as indicated below with effect from 01.04.2012.
