The attention of all the Regional Joint Directors of School Education and
Dist. Educational Officers in the State is invited to the subject and references
cited and they are again informed that the following decisions have been taken in
regard to promotions to the recently sanctioned posts of Headmasters and
School Assistants under R.M.S.A.

1. Posting orders consequent on promotions shall be issued on a purely
temporary basis subject to review at future date and outcome of
pending court cases.
2. The qualifications prescribed in G.O.Ms.No.4, dated: 09-01-2012 for
the posts of School Assistants shall be made applicable for
appointment by the method of promotion also, except in regard to
study of concerned subjects at Intermediate level.
- 3 The reservation in promotions for differently abled employees as
ordered in G.O.Ms.No.42 W.C.D.S., Deptt., dated: 19-10-2011 shall be
implemented in the ensuing promotions.
4. Posting orders to all Headmasters and School Assistants who get
promotions in the counseling scheduled from 18-01-2012 shall be
issued with a common date of relief i.e., on 23-01-2012, irrespective of
date of counseling.

The Regional Joint Directors of School Education and District Educational
Officers in the State are requested to take action accordingly.

Further, the District Education Officers and Regional Joint Directors of
School Education are instructed to incorporate the decisions/conditions at S.No.
1 and 4 as mentioned above in the promotion orders and also instructed to follow
the decision at S.No 3 in the present promotions counseling. .

These instructions should be followed scrupulously.
