### **ORDER:**

According to Rule 4 (d) of the A.P. Employees Welfare Fund Rules, 1980, Every member of the Fund shall contribute a sum of Rs. 10/- per annum. This annual contribution shall be recovered from the pay of the member for the month of March payable in April each year.

- 2. In the meeting of XX State Level Committee of A.P. Employees Welfare Fund held on 19.1.2006, it has been decided to enhance the contribution of the members from Rs. 10/- to Rs.20/- per annum and it was decided to give effect to the above decision from 2006.
- 3. In pursuance of the above decision, the following Amendment is issued to A.P. Empmloyees Welfare Fund Rules, 1980.

#### **AMENDMENT**

For Rule 4(d) of the A.P. Employees Welfare Fund Rules, 1980, the following shall be substituted namely, "Every member of the fund shall contribute a sum of Rs. 20/- (Rupees Twenty only) per annum. This contribution shall be recovered from the

pay of the member for the month of Mach payable in April each year commencing from 2006.

The amount recovered shall be credited to the Head of Account. "8121 - General and Other Reserve Fund MH117 "Employees Welfare Fund" (Andhra Pradesh State). If the annual contribution is recovered at Rs. 10/- from the pay of the members during March, 2006 towards Employees Welfare Fund, then, the balance of Rs. 10/- shall be recovered from the Pay of the members for the month of April, 2006. However, from the year 2007 onwards, the contribution at Rs. 20/- shall be recovered from March itself, from the pay of the members of the A.P. employees Welfare Fund".
