**SUBJECT:** REGIONAL YOUTH AND CSO DIALOGUE – June 23-27, 2014

1. The Secretariat of the Pacific Community (SPC) is pleased to advise that a coalition of regional partners, including the Secretariat of the Pacific Community's Regional Rights Resource Team (RRRT), UNDP Pacific Centre, Pacific Youth Council and the Pacific Islands Forum Secretariat (PIFS) will be convening a Youth and civil society dialogue to be held from 23-27 June in Nadi, Fiji (venue TBC).
2. The Secretariat of the Pacific Community alongside its regional partners is holding this dialogue in order to enhance the engagement of civil society and youth into both regional and international dialogues, forum meetings and UN reporting mechanisms including the UN Human Rights Commissioner's Universal Periodic Human Rights review process.

### OBJECTIVES

3. The purpose of the Civil Society and Youth Dialogue is to bring together a broad range of Civil Society Organisations (CSOs) and Youth representing a wide range of human rights, governance and security focal areas with the shared objectives of:

- a. Increasing capacity of participants to work closely with government and regional and international bodies through improved lobbying and advocacy skills;
- b. Increasing opportunity through the provision of a dialogue forum for Pacific youth and civil society to discuss key human rights issues related to good governance, peace, conflict and security;
- c. Enhancing opportunity for greater youth and civil society issues to be voiced at both regional and international processes including: PIFS meetings, SIDS Conference and the Universal Periodic Review of Human Rights; and
- d. Increasing the capacity of civil society and youth to monitor, promote, protect and advocate for human rights and good governance standards.

#### **INVITATION AND COMPOSITION OF DELEGATION**

4. We are very pleased to invite one representative from Civil Society and one youth representative from each of the following Pacific Island Countries : Cook Islands, Federated States of Micronesia, Fiji, Kiribati, Nauru, Niue, Palau, Papua New Guinea, Republic of Marshall Islands, Samoa, Solomon Islands, Tonga, Tuvalu and Vanuatu.
5. Criteria for selecting CSO and youth representatives include gender and disability inclusion and will be based on the following:
  - Must be active and involved in the protection and promotion of human rights work and human security issues evidenced by participation in youth councils or human rights reporting such as UPR work, or lobbying campaigns at the national level;
  - National stature and credibility evidenced by participation in regional networks, such as the Pacific Youth Council and related to their key issues;
  - Good working relationships with other CSOs and youth networks and a good knowledge of both local and regional issues;
  - Be willing to disseminate what they have learned through individual lobbying and advocacy and share experiences with other national CSOs and youth bodies.
6. #### **OTHER INVITATIONS**

7. Other development partners and organisations that have supported the work of SPC and PIFS on CSO dialogue and human rights will be invited to attend as observers.

#### **AGENDA**

8. A formal agenda / programme will be distributed to the nominated representatives prior to the meeting.

#### **LANGUAGE**

9. The Regional CSO and Youth Dialogue will be conducted in English.

#### **DATE AND VENUE**

10. The Regional CSO Dialogue will be in Fiji but venue will be confirmed soon once we notify the successful applicants. The dates for the CSO Dialogue are: 23-27 June. All logistical arrangements will be coordinated by SPC RRRT.

#### **TRAVEL, ACCOMODATION AND FINANCIAL ARRANGEMENTS**

11. SPC RRRT in partnership with **UNDP Pacific Centre, Pacific Youth Council, Pacific Islands Forum Secretariat (PIFS) and European Union**, will fund the travel, accommodation and per diem costs of those representatives outlined in paragraph 4 above in accordance with the Secretariat policies.
12. SPC RRRT will meet the cost of a return economy class excursion air fare to Suva by the most direct route.
13. SPC RRRT will arrange and pay for accommodation directly with the hotel. If a participant wishes to make his/her own accommodation arrangement at his/her cost, he/she is required to advise the Secretariat well in advance.
14. A daily per diem, less accommodation and workshop meals cost, will be paid to each funded participant during the meeting by SPC RRRT.
15. PIFS will be funding all catering arrangements during the one week CSO dialogue.
16. Observers attending the CSO Dialogue will be self-funded.

#### **VISA REQUIREMENTS**

17. As this Regional CSO Dialogue will be held in Suva, Fiji, it is imperative that all nominees sort out all necessary documentation if they require a visa-to enter Fiji. Responsibility for the Visa application process rest with the nominee. We will reimburse the cost of the visa upon submission of an original receipt (s). We will provide the nominee(s) with their travel itinerary. We recommend that each confirmed nominee checks with their relevant national authority for visa requirement for Fiji.

#### **TELECOMMUNICATION**

18. Telephone, fax and internet facilities are available at hotels. Charges for all telephone calls, faxes and internet use are the responsibility of the representatives incurring them

#### **POWER SUPPLY**

19. Fiji power supply operates at 230 volts

#### **CURRENCY**

20. Fiji uses the Fijian Dollar as its domestic currency. Most international credit cards are widely accepted. Exchange rates in the local banks vary daily (info readily available at respective banks and hotels). Travellers' cheques can be cashed at hotels or at any bank.


## **CLIMATE**
