Subject: Advisory for disbursement of wage payment to wage seekers of all category (SC, ST and Others) through single FTO from FY 2022-23-reg.

2. Meeting with All States/UTs Commissioners (Mahatma Gandhi NREGA) under the chairpersonship of Joint Secretary (Mahatma Gandhi NREGA) on 29.3.2022 through VC.

Madam/Sir,

I am directed to convey that the process for generation of separate FTOs for (SC, ST and Others) category will be withdrawn from the 1st April, 2022.

2. From 1st April, 2022 there will be single FTOs for all category of workers under Mahatma Gandhi NREGA.


3. In connection with this State/UT are requested to take the following steps:

- i. State to ensure deactivation of Ne-FMS account for SC and ST in NREGASoft.
- ii. Deactivation(marking as not in use) of Ne-FMS account in PFMS by the State/UT.
- iii. Return of interest, if any in the bank account for Ne-FMS SC and ST to this Ministry by the State/UT.
- iv. After making the balance zero in the account for Ne-FMS SC and ST, State/UT should close this account having a copy of bank statement as on 31st March, 2022 and also a copy of UC against the fund released for these category during the FY 2021-22 to be shared with this Ministry.

- v. State/UT to ensure that the existing "Ne-FMS-Others" category account will be declared as State Nodal Ne-FMS Account for wage payment.
- vi. State/UT will share the category-wise trifurcated projected LB on the basis of total Annual LB and the data entry for projected LB against the category (SC, ST and Others) will be ensured by States/UTs in the NREGAssoft.
- vii. Monthly projection of different category may be revised within the overall ceiling of Annual LB with approval of competent authority of this Ministry.
- viii. Single Utilisation certificate (UC) containing funds released and utilisation of all category(SC,ST,Others) as per daily section orders issued by the MoRD.

This issues with the approval of competent authority.


