Analysis of Election Expenditure Statements of MLAs **Punjab Assembly Elections, 2017**

According to Section 78 of the Representation of the People Act, 1951, every contesting Winner has to lodge a true copy of his election expenses within 30 days from the date of declaration of result of election, with the District Election Officer in all States and Union Territories. Punjab Election Watch and Association for Democratic Reforms (ADR) have analyzed all the election expenditure statements submitted after the Punjab 2017 Assembly for 117 MLAs. The expenditure limit for the Winners during the Punjab Assembly elections was Rs. 28 lakhs. These election expense documents include *details of expenses on public meeting and processions, campaigning through electronic and print media, expense on campaign workers, expense on vehicles used and expense on campaign materials.*

Recommendations:

1. Each Winner is required to file his election expenditure statement within 30 days of the results of the elections, the deadline in case of the Punjab Assembly Elections being the 10th April, 2017. However, it was observed that the election expenditure statements of the Winners were not uploaded on the CEO website till significantly after the deadline. **It is therefore recommended that the Abstract Expenditure Statement (Annexure 15) of the Winners is uploaded on the website of the CEO within 72 hours of the receipt of the statement.**
2. The deadline for filing an election petition against any Winner is 45 days after the declaration of the results. Generally, Winners submit their election expenditure statements towards the end of the 30 days given for submission of the statements. This leaves 15 days for any common citizen to file an election petition against any Winner. The deadline for filing an election petition should be increased in order to give the citizens time to scrutinize the election expenditure statements of the Winners and gather the relevant documents/proof etc for the election petition.
3. As has been instated in the filing of affidavits during the elections, the Winners should not be allowed to keep any field blank on the Abstract Election Expenditure statement (Annexure 15) and Schedule 1 to 9. The statements must be filled in a legible format and overwriting of amounts in the statement should be discouraged.

Summary and Highlights of Election Expenses of MLAs from the Punjab Assembly 2017 Elections

1. **Less than 50% of the Limit:** Out of 117 MLAs analysed, **46(39%)** MLAs have declared election expenses of less than 50% of the expense limit in their constituency.
2. **Average Election Expenses:** Based on the election expense declarations of 117 MLAs from Punjab Assembly, the average amount of money spent by them in the elections is **Rs 15.34 lakhs, which is 55% of the expense limit.**
3. **Party-wise Average Election Expenses:** The party wise average election expenses shows that the average spending for **77 MLAs from INC** is **Rs 15.25 lakhs** (54.5% of the expense limit). For **20 MLAs from AAP**, the average election expenditure is **Rs 14.86 lakhs** (53% of the expense limit), for **15 MLAs from SAD**, it is **Rs 15.76 Lakhs** (56% of the expense limit), for **3 MLAs from BJP** it is **Rs 15.49 Lakhs** (55% of the expense limit), and for **2 MLAs from Lok Insaaf Party**, the average election expenditure is **Rs 20.01 Lakhs** (71.5% of the expense limit).

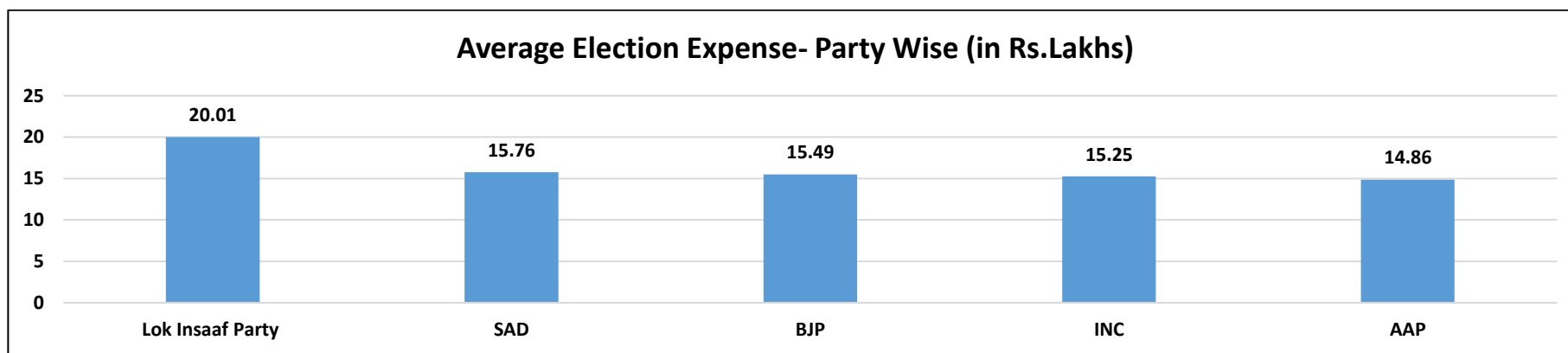
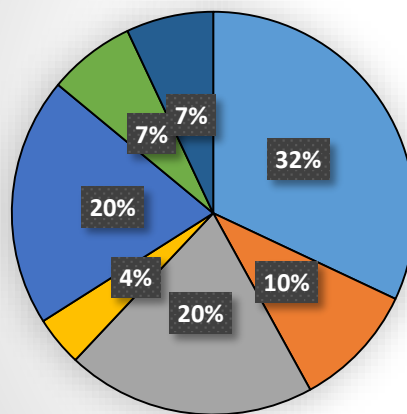


Figure 1: Party-wise Average Election Expenses (Rs. in lakhs)

3. Expense on Public Meeting, Rally, and Processions with Star Campaigners: Out of the 117 MLAs analyzed, **45 (38%) MLAs** have declared that they have not spent any amount on public meetings, processions etc with star campaigners.

4. Expense on Campaigning through electronic/print media: **50 (43%) MLAs** have declared that they have not spent any amount on campaigning through electronic/print media.

5. Expense on Campaign Workers: **35 (30%) MLAs** have declared that they have not spent any amount on campaign workers.

6. Expense on Vehicles used: **1 MLA** has declared that he has not spent any amount on vehicles during the campaign.

7. Expense on Campaign Materials: **8 (7%) MLAs** have declared that they have not spent any amount on campaign materials.

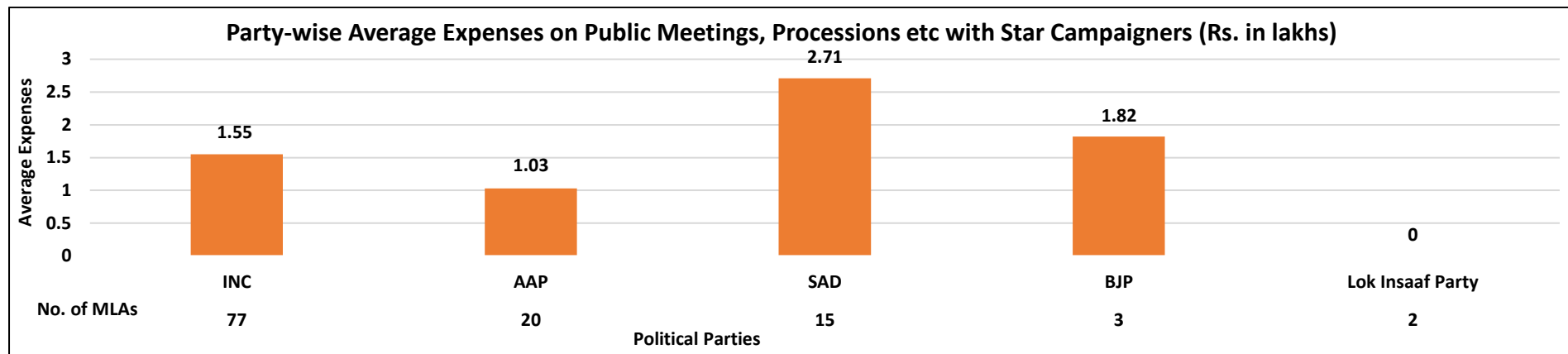


Figure 2: Party-wise Average Expenses on Public Meetings, Processions etc with Star Campaigners (Rs. in lakhs)

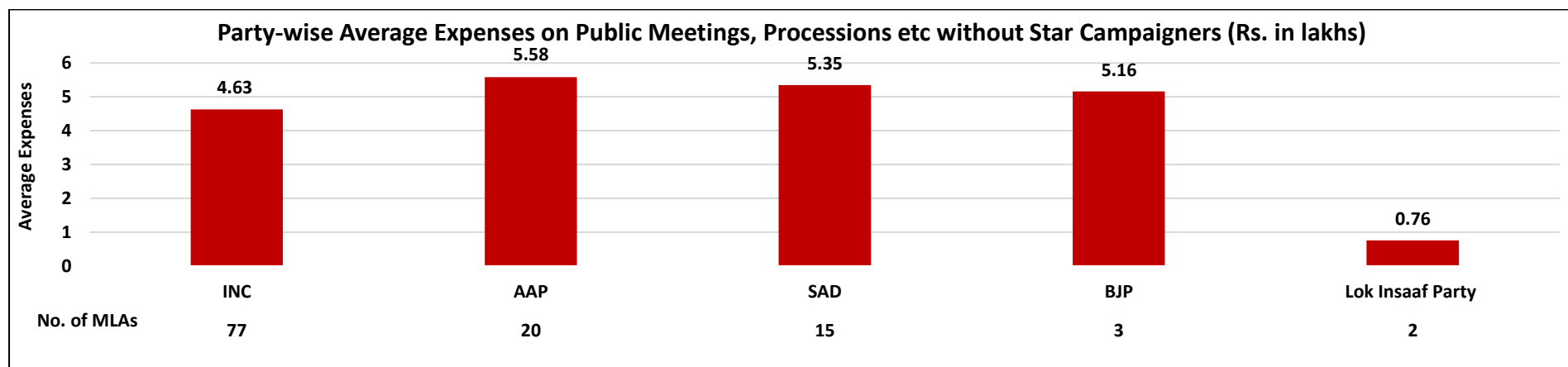


Figure 3: Party-wise Average Expenses on Public Meetings, Processions etc without Star Campaigners (Rs. in lakhs)

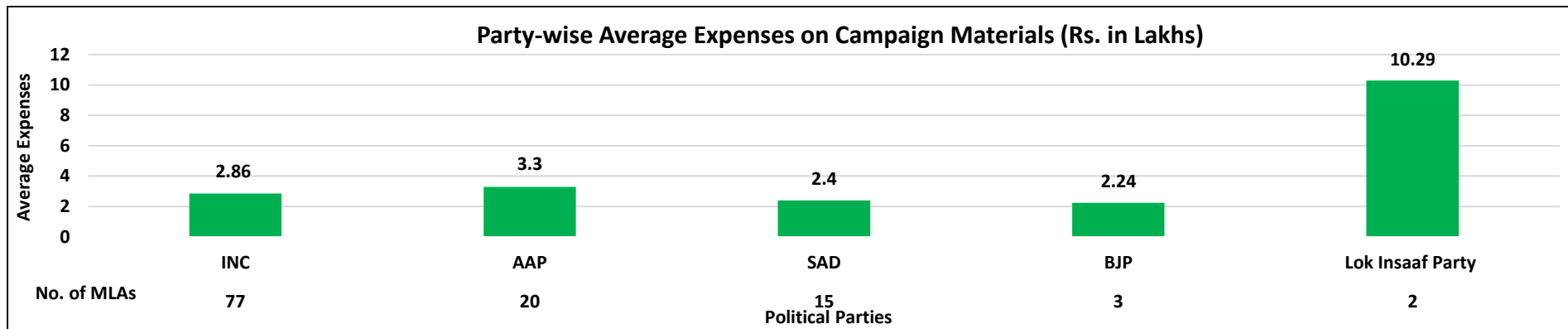


Figure 4: Party-wise Average Expenses on Campaign Materials (Rs. in lakhs)

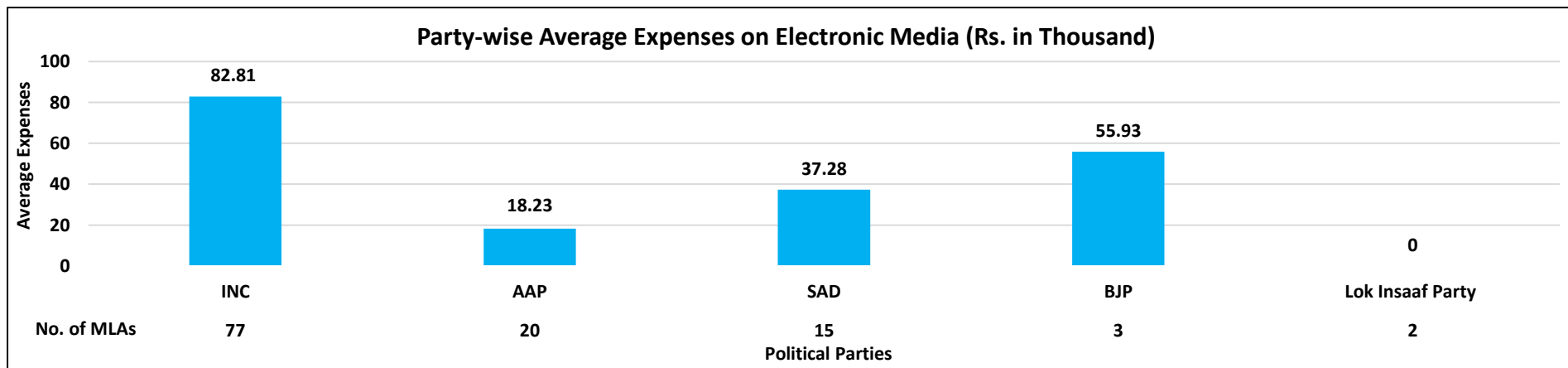


Figure 5: Party-wise Average Expenses on Electronic Media (Rs. in thousand)

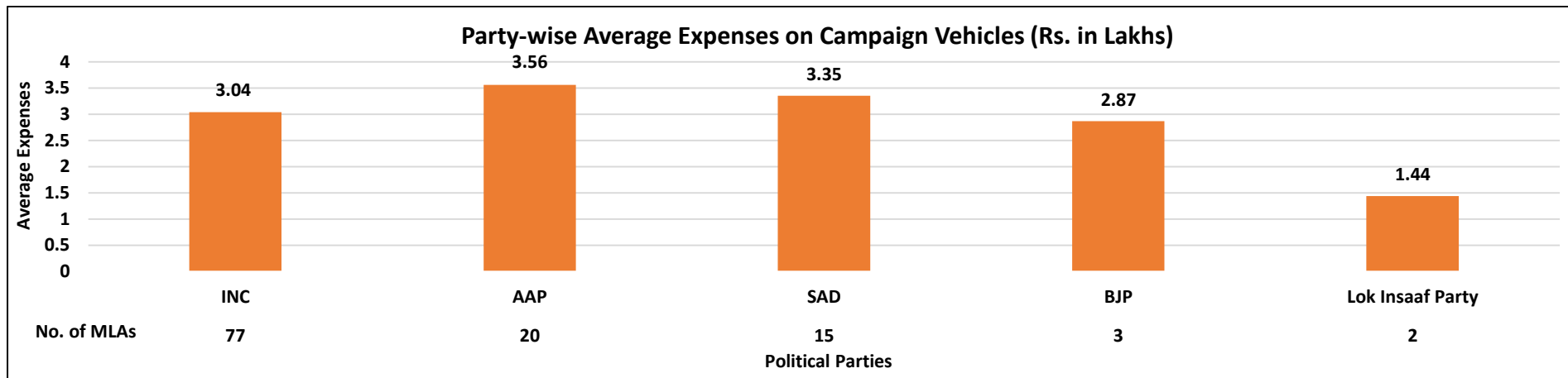


Figure 6: Party-wise Average Expenses on Campaign Vehicles (Rs. in lakhs)

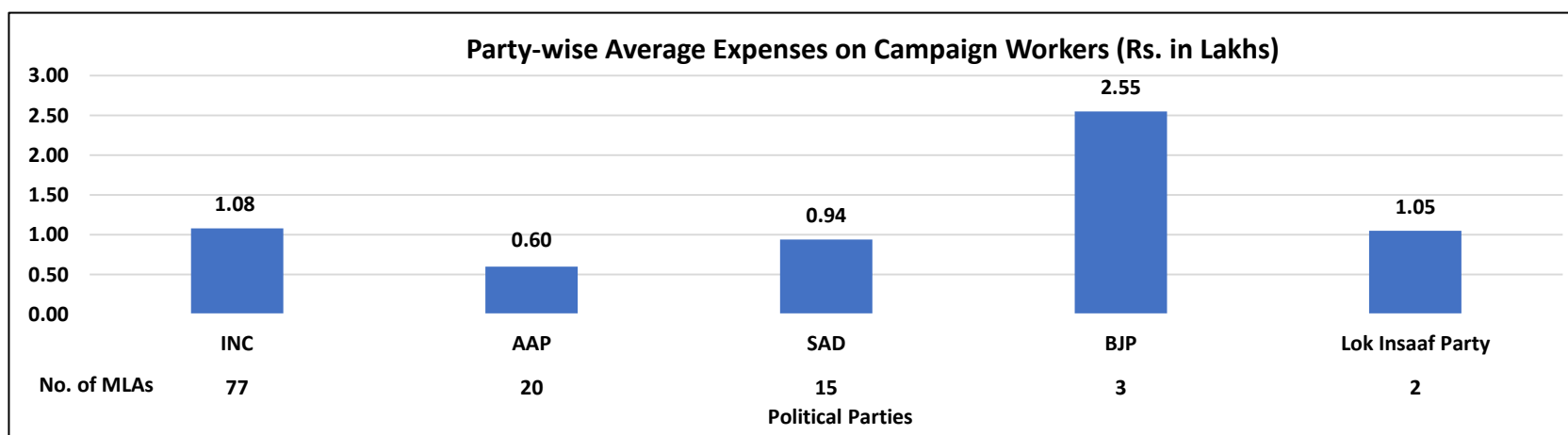


Figure 7: Party-wise Average Expenses on Campaign Workers (Rs. in lakhs)

Summary and Highlights of Funds Raised by MLAs in the Punjab Assembly 2017 Elections

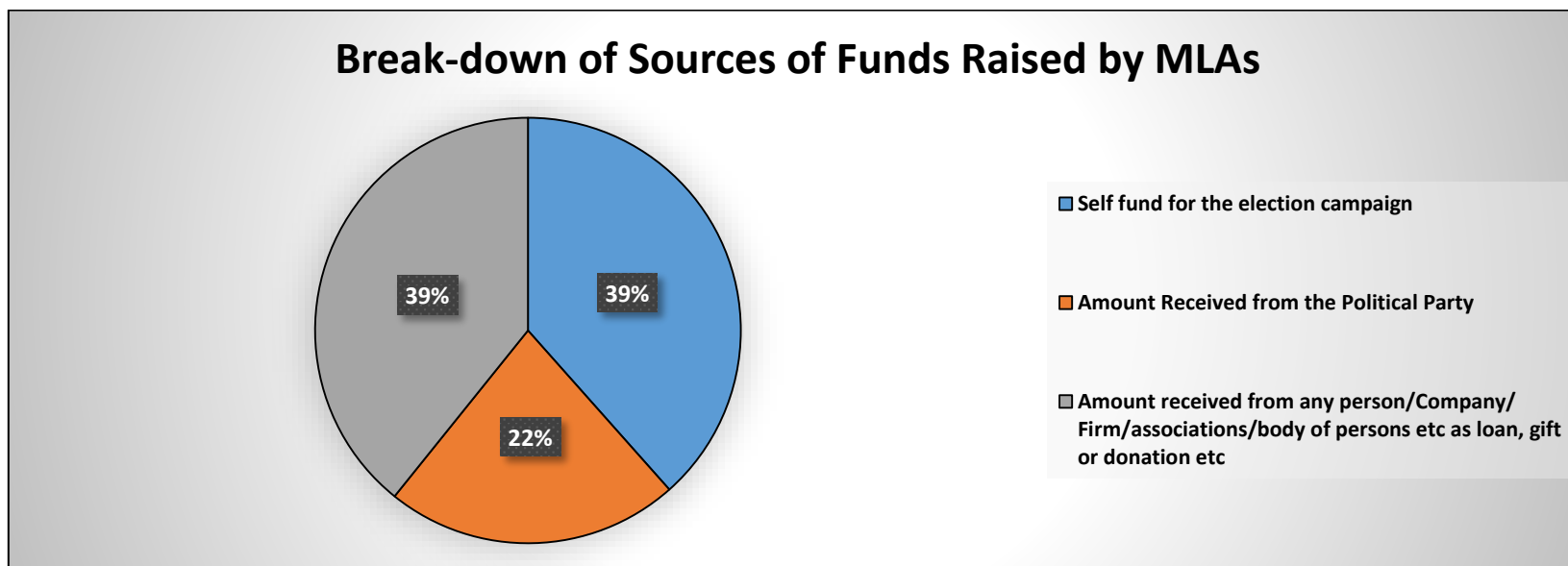


Figure 8: Percentage Break-down of Funds Raised by MLAs

1. **Percentage break-down of funds received by MLAs:** Out of the total funds received by MLAs, 22% funds were raised from political parties, 39% were raised by MLAs themselves and 39% funds were raised from other sources.
2. **MLAs Who Raised Funds from Political Parties:** Out of the 117 MLAs analyzed, 69(59%) MLAs have declared that they have not received any funds from political parties.
3. **MLAs Who Raised Funds through any person/ company/ firm/ associations/ body of persons etc as loan, gift or donation etc:** Out of the 117 MLAs analyzed, 17(14.5%) MLAs have declared that they have not received any funds from any person/ company/ firm/ associations/ body of persons etc as loan, gift or donation etc.

4. **Self funds used for election campaign:** Out of the 117 MLAs analyzed, **5 (4%) MLAs** have declared that **they have not used any of their own funds for their election campaign.**
5. **Average funds raised from Political Parties (Party-wise):** On an average a **MLA from INC raised 46 % of his/her election expense funds from the political party.** Similarly, on an average **a MLA from AAP raised 39%** of his/her election expense funds, a MLA from **SAD raised 0.86 %**, a MLA from **BJP raised 26 %** and a MLA from **Lok Insaaf Party raised 3 %** of their election expense funds from the political party.
6. **Average funds raised through any person/company/firm/associations/body of persons etc as loan, gift or donation etc (Party-wise):** On an average a MLA from **INC raised 33%** of his/her election expense funds from any person/company/firm/associations/body of persons etc as loan, gift or donation. Similarly, a MLA from **AAP raised 45%** of his/her election expense funds, a MLA from **SAD raised 71%** of his/her election expense funds, a MLA from **BJP raised 60%** of his/her election expense funds and a MLA from **Lok Insaaf Party raised on an average 38%** of their expense funds from any person/ company/ firm/ associations/ body of persons etc as loan, gift or donation.

Summary and Highlights of Election Expenses of Ministers from the Punjab Assembly Elections, 2017

- Less than 50% of the Limit:** Based on the election expense declarations of all 10 Ministers analysed from Punjab Assembly 2017, **2 Ministers (20%)** have declared election expenses of less than 50% of the expense limit in their constituency.
- Average Election Expenditure:** Based on the election expense declarations of all 10 Ministers from Punjab Assembly 2017, the **average amount of money spent** by them in the elections is about **Rs 17.56 lakhs, which is 63% of the expense limit**.

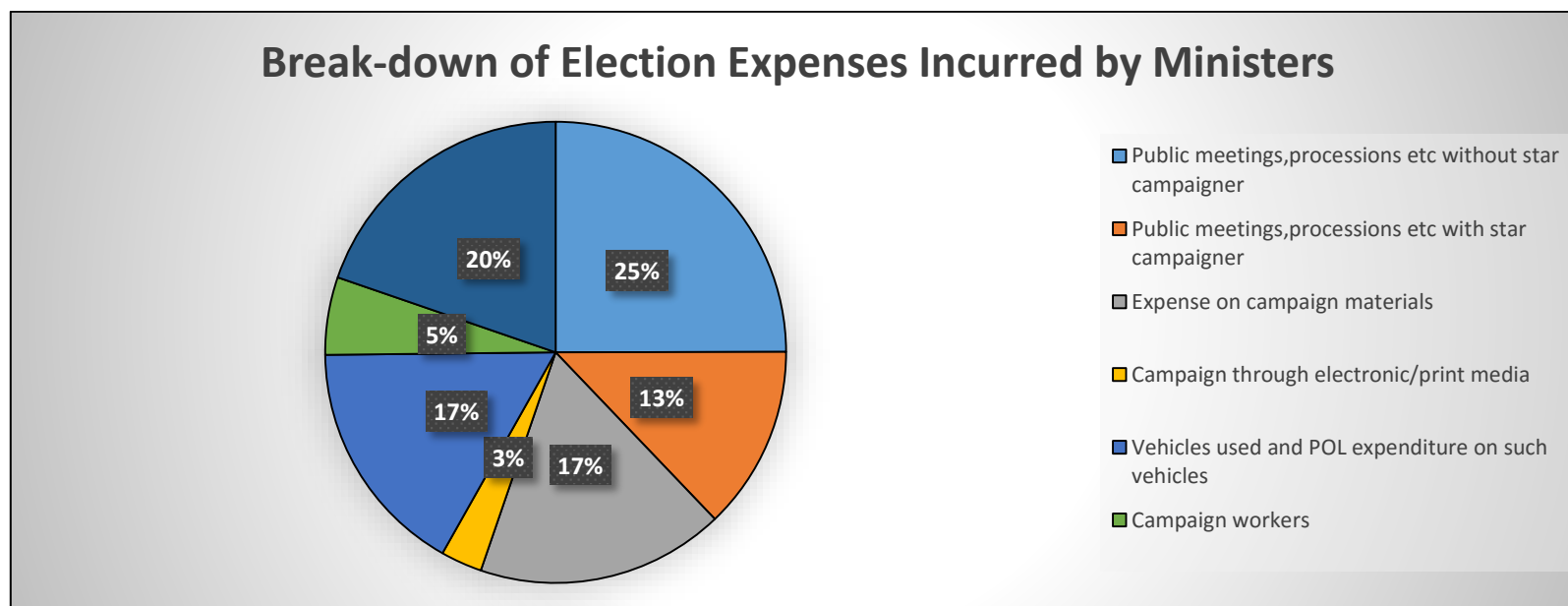


Figure 10: Break-down of Election Expenses Incurred by Ministers

1. **Expense on Public Meeting, Rally, and Processions with Star Campaigners:** 4 (40%) ministers have declared that they have not spent any amount on public meetings, processions etc with star campaigner.
2. **Expense on Public Meetings, Rally, and Processions other than the ones with Star Campaigners:** 1(10%) minister has declared that he has not spent any amount on public meetings, processions etc other than the ones with star campaigners
3. **Expense on Campaigning through electronic/print media:** 3 (30%) ministers have declared that they have not spent any amount on campaigning through electronic/print media.
4. **Expense on Campaign Workers:** 4(40%) Ministers have declared that they have not spent any amount on campaign workers.
5. **Expense on Campaign Materials:** 1 (10%) minister has declared that he has not spent any amount on Campaign Materials.

Summary and Highlights of Funds Raised by Ministers in the Punjab Assembly 2017 Elections

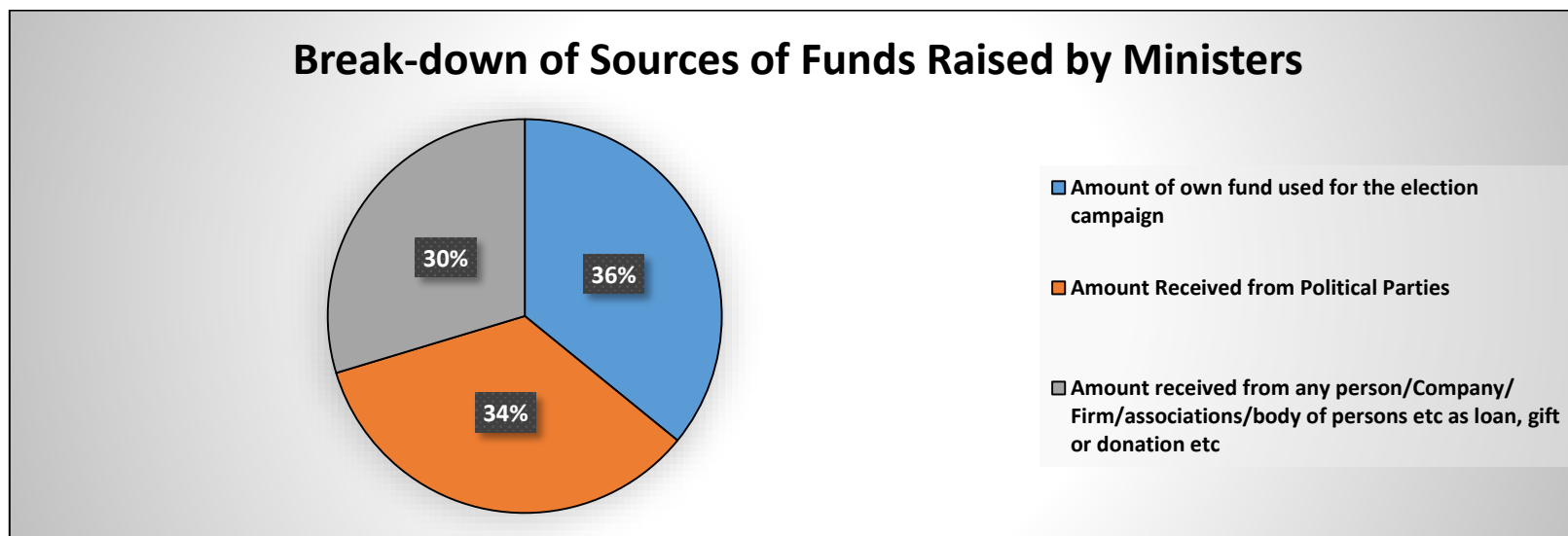


Figure 11: Percentage Break-down of Funds Raised by Ministers

1. **Percentage break-down of funds received by Ministers:** Out of the total funds received by Ministers, **34% funds were raised from political parties, 36% were raised by Ministers themselves and 30% funds were raised from other sources.**
2. **Ministers Who Raised Funds from Political Party:** Out of the all 10 Ministers analyzed, **7 (70%) Ministers** have declared that **they have not received any funds from political parties.**
3. **Ministers Who Raised Funds through any person/ company/ firm/ associations/ body of persons etc as loan, gift or donation etc:** Out of the 10 Ministers analyzed, **2 (20%) Ministers** have declared that **they have not received any funds from any person/ company/ firm/ associations/ body of persons etc as loan, gift or donation etc.**
