Analysis of Newly Elected MLAs of 2016 Assembly Elections in Tamil Nadu, Kerala, Assam, West Bengal and Puducherry

 National Election Watch (NEW) groups in the five states of Tamil Nadu, Kerala, Assam, West Bengal and Puducherry have analyzed the affidavits of 812 MLAs elected in the 2016 Assembly elections. Election Commission of India (ECI) has postponed elections in 2 constituencies in Tamil Nadu (174- Thanjavur and 134-Aravakurichi Assembly Constituencies). Affidavits for 9 MLAs in Tamil Nadu were badly scanned and hence not analyzed at this time.

- 36% MLAs (294 out of 812 analyzed) have self-declared pending criminal cases as per their affidavits in Tamil Nadu, Kerala, Assam, West Bengal and Puducherry 2016 Assembly Elections.
- 176 MLAs out of these 812 analyzed have declared serious IPC charges like murder and attempt to murder charges against them.
- Kerala has the maximum percentage (62%) of MLAs with declared criminal cases against them.
- West Bengal has the maximum percentage (32%) of MLAs with declared serious criminal cases against them.
- A total of 428 MLAs (i.e. 53% of the total analyzed) are crorepatis.





- Puducherry has the maximum percentage (83%) of MLAs who are crorepatis, followed by Tamil
 Nadu with 76% of MLAs who are crorepatis.
- A total of 186 MLAs (23%) have declared that they have never filed Income Tax Returns (ITR).
- Kerala has the maximum percentage (60%) of MLAs who have not filed income tax, followed by West Bengal with 20% of MLAs who not filed income tax.
- 49 MLAs have not even given their PAN details.
- Puducherry has the highest average assets (Rs 13.45 crores) of MLAs followed by Tamil Nadu with average assets of Rs 8.21 crores and Kerala with average assets of Rs 2.82 crores.
- Out of 812 newly elected MLAs, there only 9% women MLAs. Among the five states, West Bengal has 40 out of 293 (14%) women MLAs, followed by Puducherry with 4 of 30 (13%).
- There are 19 MLAs with PhD. The maximum number of MLAs (10) with PhD are from West Bengal followed by Tamil Nadu with 5 MLAs who have a PhD.
- Apart from PhD, there are 480 or 59% MLAs with Graduate or above Degrees.
- 11% of the elected MLAs are 40 and below years of age
- 5 MLAs are above 80 years of age

Analysis Based on Declared Criminal Cases

Declared Criminal Cases against MLAs

- There are 294 MLAs out of the 812 analyzed, (i.e. about 36%) who have declared criminal cases against them as per their self sworn affidavits given to the Election Commission.
- Out of the 294 MLAs analyzed who have declared criminal cases, 176 have declared serious criminal cases like murder, attempt to murder, kidnapping, robbery, extortion etc. on them.

Analysis Based on Assets

A total of 428 MLAs out of 812 analyzed i.e. 53% of the total number of MLAs (analyzed) elected in the 5 states are crorepatis. 83% of MLAs analyzed of Puducherry are crorepatis followed by 76% of MLAs of Tamil Nadu and 57% of MLAs of Assam.

Analysis of Income Tax and PAN details of MLAs in five Assembly Elections

- A total of 186 MLAs (23%) out of 812 MLAs analyzed have declared that they have never filed Income Tax Returns.
- 49 MLAs have not even given PAN details.

State-wise MLAs who have not filed Income Tax Returns (ITR)

Out of 812 MLAs analyzed, 186 MLAs (23%) have declared that they not filed Income Tax Returns. They include 60% of MLAs from Kerala followed by 20% from West Bengal and 14% MLAs from Tamil Nadu.
