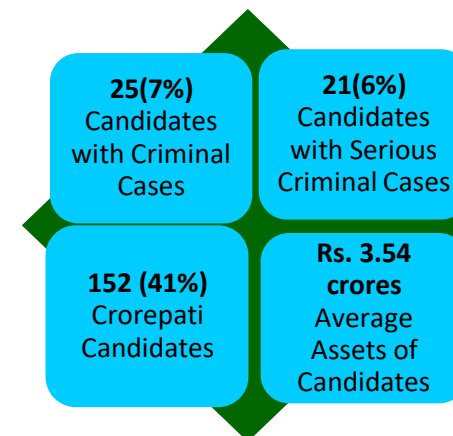

## Summary and Highlights

Meghalaya Election Watch and Association for Democratic Reforms (ADR) have analysed the self-sworn affidavits of all **(370)** candidates for the Meghalaya 2018 Assembly Elections.

### Criminal Background

- **Candidates with Criminal Cases:** Out of the **370** candidates analysed, **25(7%)** candidates have declared criminal cases against themselves.
- **Candidates with Serious Criminal Cases:** **21 (6%)** candidates have declared serious criminal cases against themselves.
- **Candidates with cases related to murder:** **1** candidate namely **Nikman Ch.Marak**, a GNC candidate contesting from Baghmara constituency has declared case related to **murder (Indian Penal Code Section-302)** against himself.
- **Candidates with cases related to attempt to murder:** **3** candidates have declared cases related to **attempt to murder (Indian Penal Code Section-307)** against themselves.
- **Candidates with cases related to crime against women:** **3** candidates have declared cases related to crime against women such as **rape (IPC Section- 376); word, gesture or act intended to insult the modesty of a woman (IPC Section -509) and cohabitation caused by man deceitfully including a belief of lawful marriage (IPC Section 493).**
- **Party wise Candidates with Criminal Cases:** **4(9%)** out of 47 candidates from **Bhartiya Janta Party (BJP)**, **1 (2%)** out of 60 candidates from **Indian National Congress (INC)**, **3(6%)** out of 52 candidates from **NPP**, **4(11%)** out of 35 candidates from **United Democratic Party (UDP)**, **3(14%)** out of 21 candidates from **NCP**, **1(17%)** out of 6 candidates from **AAP** and **1(13%)** out of 8 candidates from **AITC** have declared criminal cases against themselves in their affidavits.



#### *Criteria for serious criminal cases*

1. Offence for which maximum punishment is of 5 years or more.
2. If an offence is non-bailable
3. If it is an electoral offence (for eg. IPC 171E or bribery)
4. Offence related to loss to exchequer
5. Offences that are assault, murder, kidnap, rape related
6. Offences that are mentioned in Representation of the People Act (Section 8)
7. Offences under Prevention of Corruption Act
8. Crimes against women.

- **Party wise Candidates with Serious Criminal Cases:** 4(9%) out of 47 candidates from **Bhartiya Janta Party (BJP)**, 1 (2%) out of 60 candidates from **Indian National Congress (INC)**, 2(4%) out of 52 candidates from **NPP**, 1(3%) out of 35 candidates from **United Democratic Party (UDP)**, 3(14%) out of 21 candidates from **NCP**, 1(17%) out of 6 candidates from **AAP** and 1(13%) out of 8 candidates from **AITC** have declared serious criminal cases including **murder, attempt to murder, rape etc.** against themselves in their affidavits.

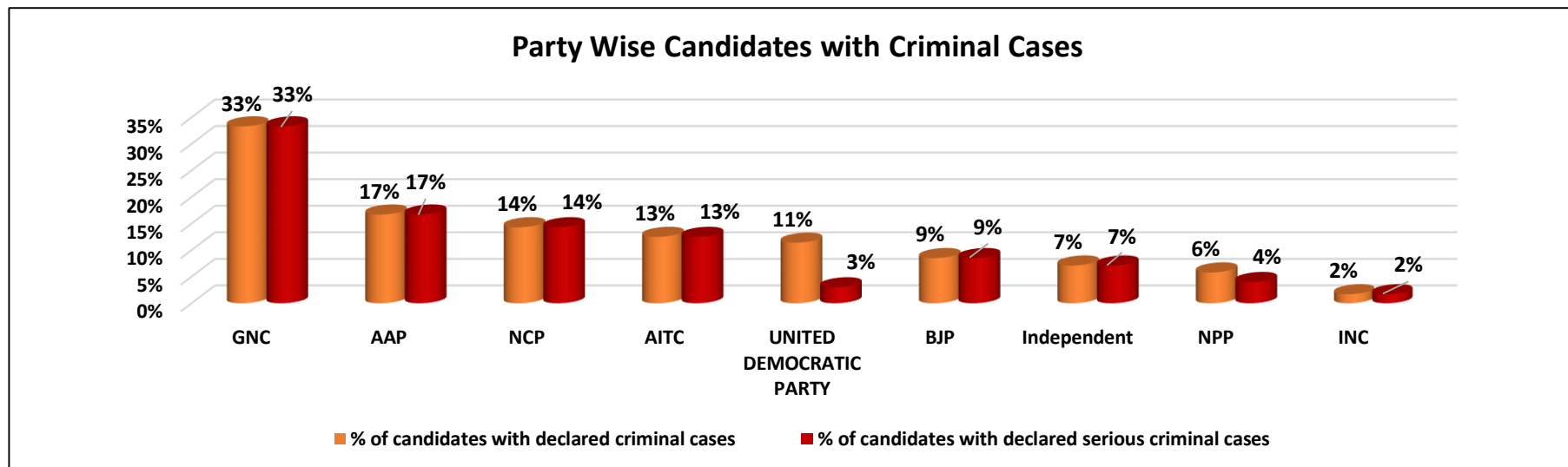


Figure 1: Party Wise Candidates with Criminal Cases

- **Red Alert Constituency:** There are 2 red alert constituencies namely **South Tura and William Nagar** in the Meghalaya Assembly Elections, 2018. *Red Alert constiuencies are the constituencies which have 3 or more candidates with declared criminal cases.*

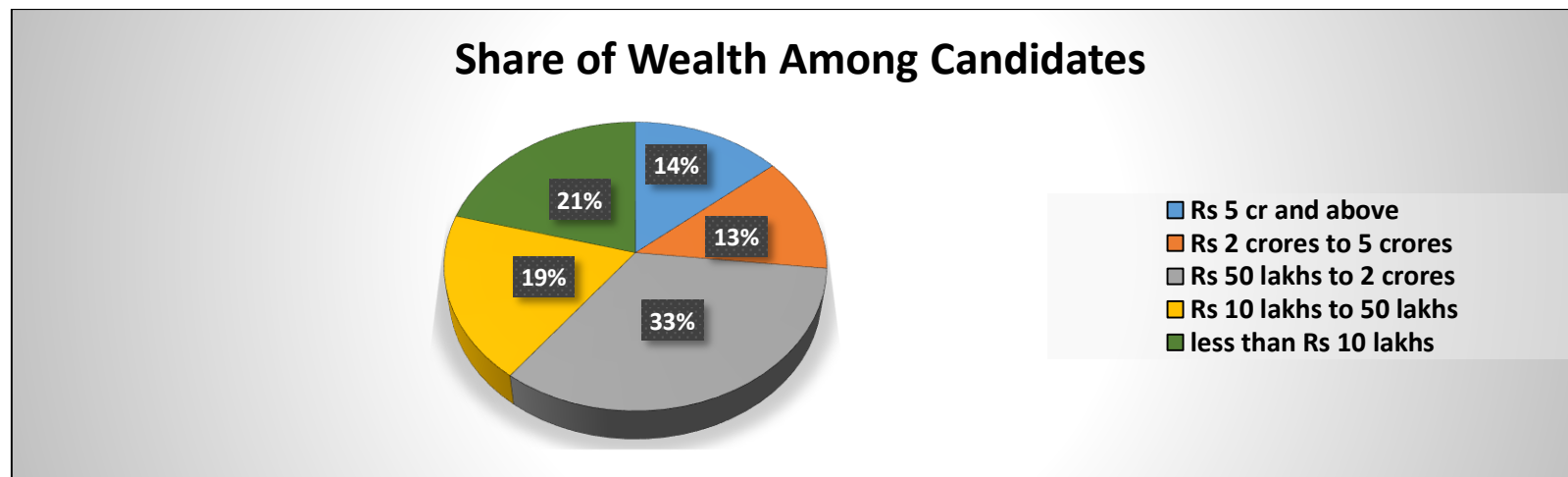


Figure 2: Share of Wealth among Candidates

- **Share of wealth among candidates** : The share of wealth amongst the candidates contesting in assembly elections of Meghalaya is as follows:

- **Crorepati Candidates**: Out of the 370 candidates analysed, **152 (41%)** are crorepatis.

- **Party wise Crorepati Candidates:** 20(43%) out of 47 candidates from **Bhartiya Janta Party (BJP)**, 35 (58%) out of 60 candidates from **Indian National Congress (INC)**, 34(65%) out of 52 candidates from **NPP**, 19(54%) out of 35 candidates from **United Democratic Party (UDP)**, 6(29%) out of 21 candidates from **NCP**, and 5(39%) out of 13 candidates from **HSPDP** have declared assets worth more than Rs. 1 crore.

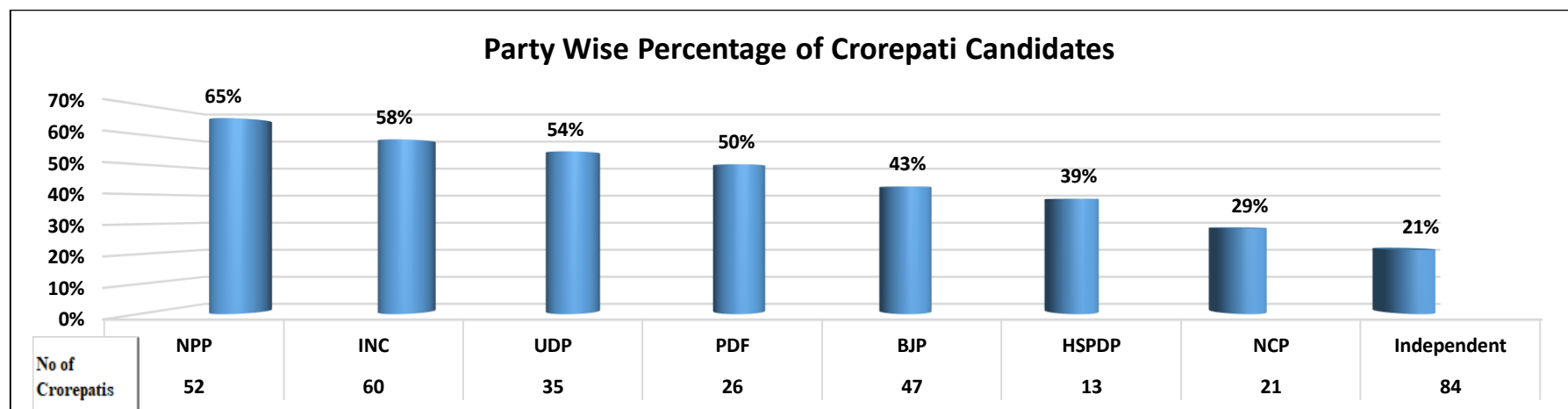


Figure 3: Party Wise Crorepati Candidates

- **Average assets:** The average of assets per candidate contesting in the Meghalaya Assembly Elections 2018 is **Rs 3.54 crores**.
- **Party wise average assets:** Among the major parties, the average assets per candidate for **60 INC** candidates is **Rs 3.25 crores**, **52 NPP** candidates have average assets of **Rs 9.70 crores**, **47 BJP** candidates have average assets worth **Rs 2.26 crores**, **35 UDP** candidates have average assets worth **Rs 4.41 crores**, **26 PDF** candidates have average assets worth **Rs 5.47 crores**, **21 NCP** candidates have average assets worth **Rs 1.22 crores** and **84 Independent** candidates have average assets of **Rs. 1.53 crores**.

- **Sources of Income:** 32 (9%) out of 370 candidates have not declared their sources of income.

### Other Background Details

- **Education details of candidates:** 151 (41%) candidates have declared their educational qualification to be between 5<sup>th</sup> pass and 12<sup>th</sup> pass, while 208(56%) candidates have declared having an educational qualification of **graduate or above**. There is 1 candidate who is **literate**.
- **Age details of candidates:** 244(66%) candidates have declared their age to be between 25 and 50 years while 126(34%) candidates have declared their age to be between 51 and 80 years.
- **Gender details of candidates:** 33 (9%) women candidates are contesting in the Meghalaya assembly election, 2018.

### Analysis based on declared criminal cases

- **Candidates with self-declared criminal cases:** Out of the **370** candidates, **25 (7%)** candidates have declared criminal cases against them, while **21(6%)** candidates have declared serious criminal cases against them.

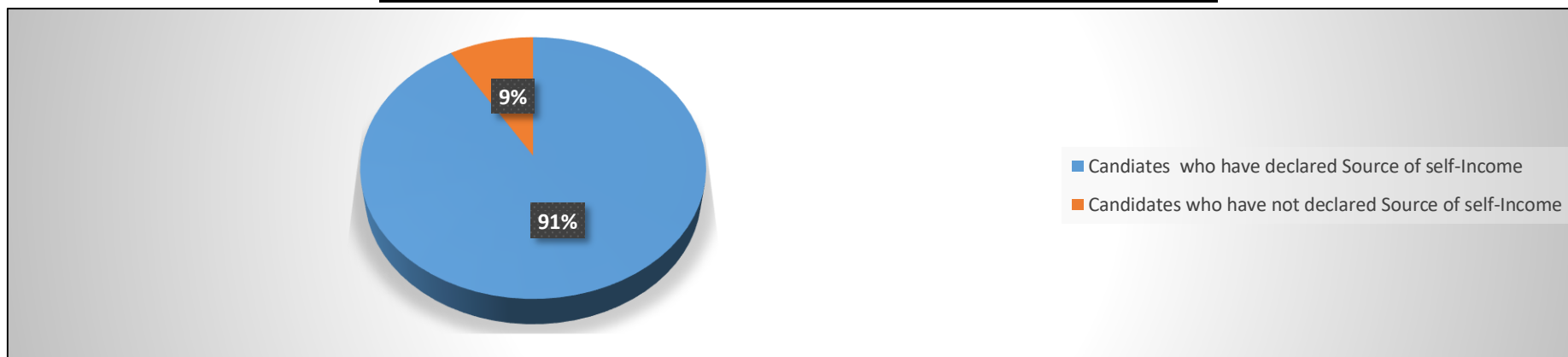


Figure 4: Candidates who have/have not declared sources of self-income

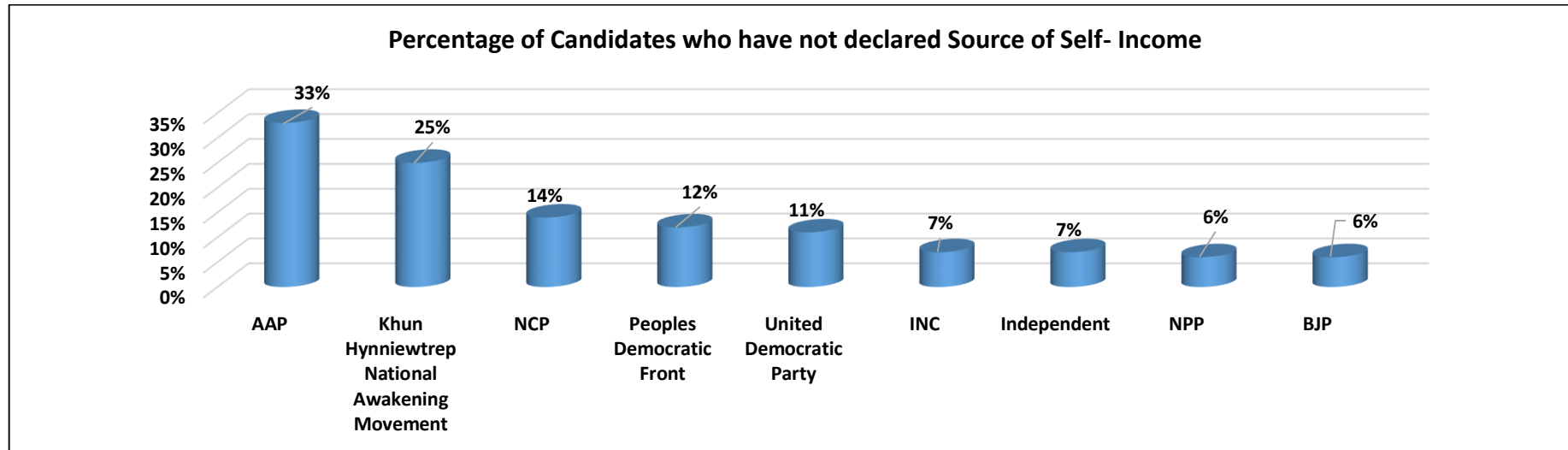


Figure: Party wise candidates who have not declared their source of self-income

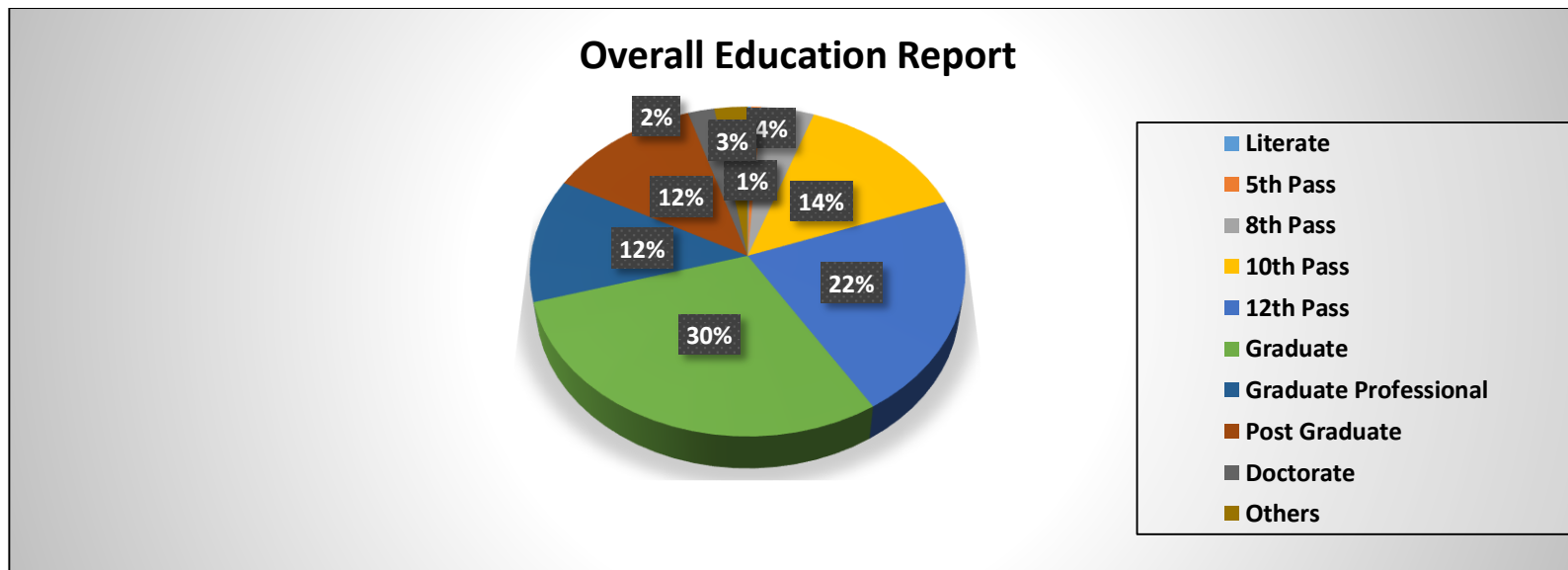


Figure: Analysis of candidates on the basis of education

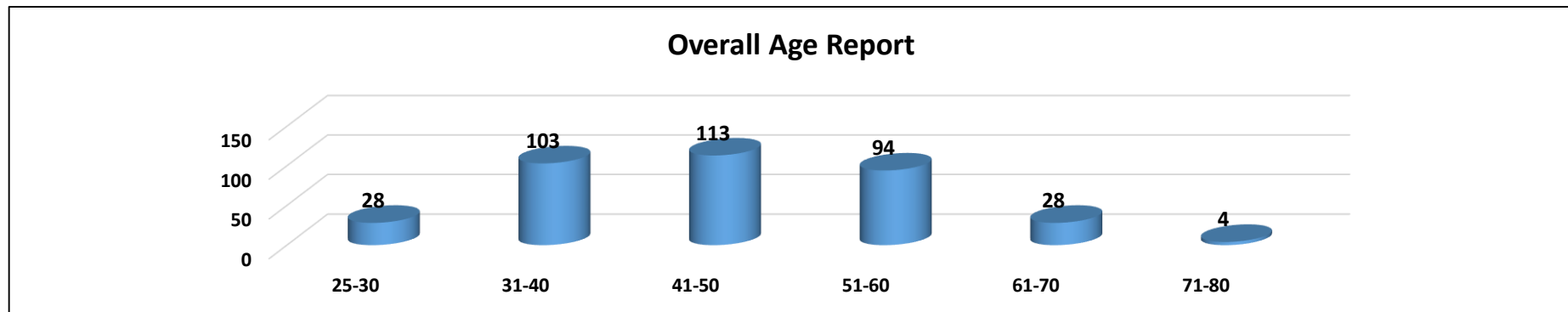
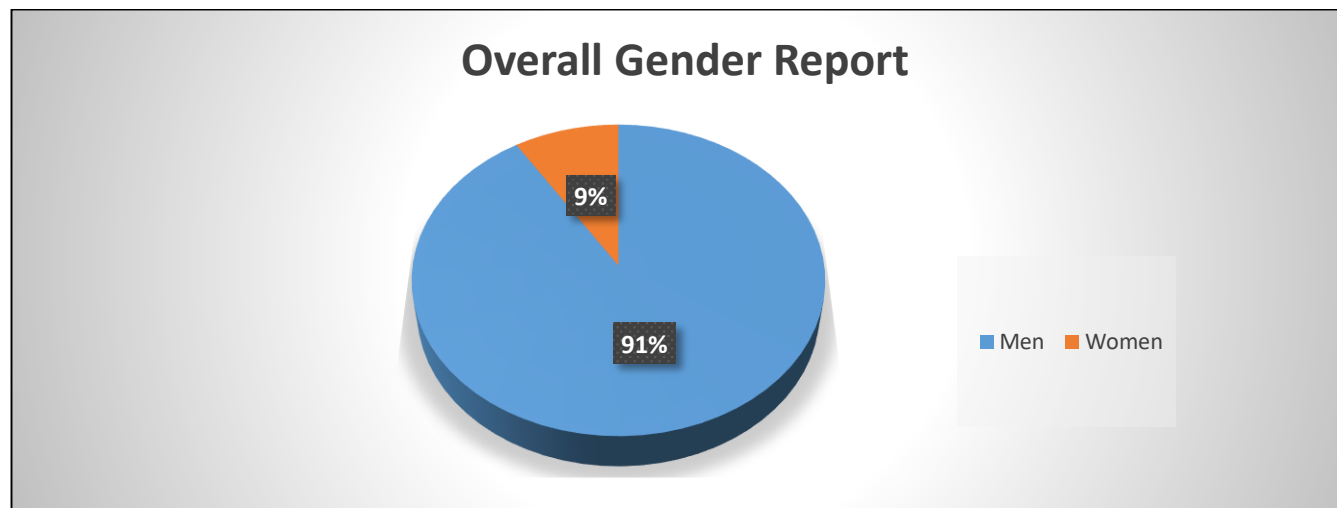


Figure: Analysis of candidates on the basis of age groups

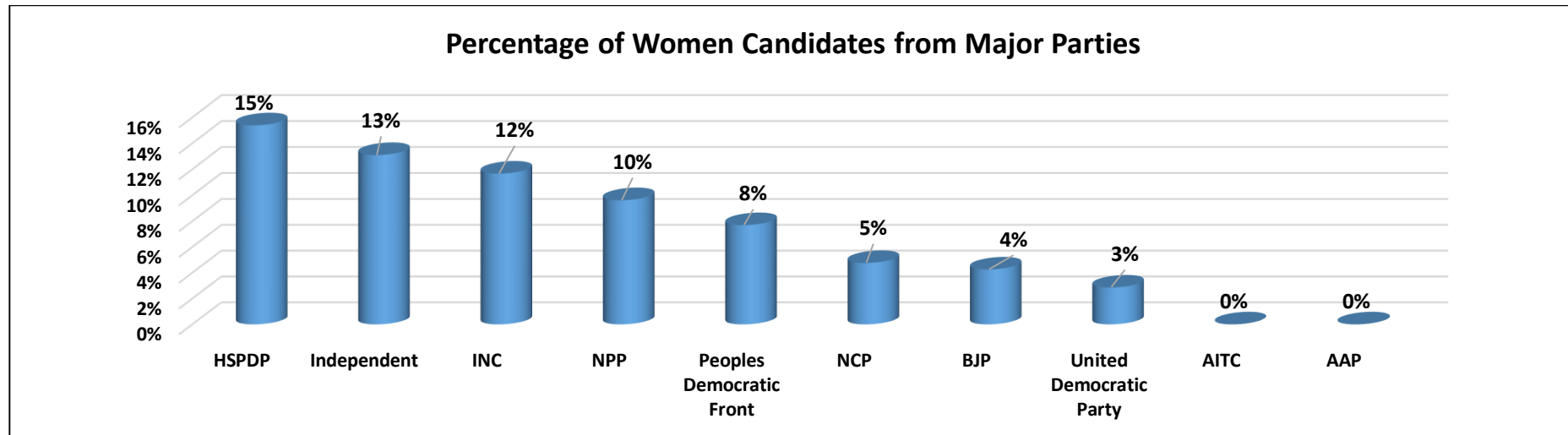


Figure: Percentage of Women Candidates from Major Parties
