Executive Summary

- **MLAs Contesting Again:** Assam Election Watch (AEW) and Association for Democratic Reforms (ADR) have analyzed the affidavits of **99 outgoing MLAs** who are contesting again in the 2016 Assam Assembly Elections.
- **Average Assets in 2011 Elections:** The average assets of these 99 re-contesting MLAs fielded by various parties including independents in 2011 were **Rs 1.33 crores** (Rs. 1, 33,75,527).
- **Average Assets in 2016 Elections:** The average assets of these 99 re-contesting MLAs in 2016 is **Rs 2.58 crores** (Rs. 2, 58, 18,964).
- **Average Asset change from 2011 to 2016:** The average assets of these 99 re- contesting MLAs, between the Assam Elections of 2011 and 2016 increased by **Rs. 1.24 crores** (1,24,43,436).
- **Percentage change in assets from 2011 to 2016** Average percentage increase in assets for these 99 re-contesting MLAs is **93%**.

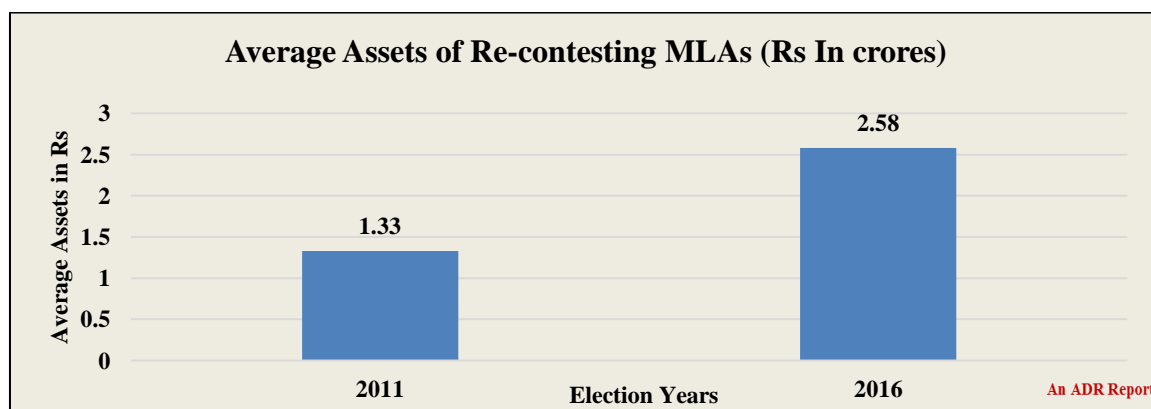


Figure 1: Average Assets of Re-contesting MLAs (in crores)
