BOROUGH OF NORTH PLAINFIELD COUNTY OF SOMERSET STATE OF NEW JERSEY

AN ORDINANCE TO AMEND, REVISE AND SUPPLEMENT THE BOROUGH CODE OF THE BOROUGH OF NORTH PLAINFIELD, CHAPTER II ENTITLED "ADMINISTRATION," MOST NOTABLY SECTION 2-3.2, ENTITLED "MEETINGS," AND CHAPTER III ENTITLED "POLICE REGULATIONS," MOST NOTABLY SECTION 3-3.2, ENTITLED "POSSESSION OF WEAPONS PROHIBITED."

WHEREAS, pursuant to *N.J.S.A.* 40:48-1 and *N.J.S.A.* 40:48-2, the governing body of a municipality may make, amend, repeal, and enforce such ordinances, regulations, rules and by-laws not contrary to the laws of this State and/or of the United States, as it may deem necessary and proper for the good of government, order, and protection of person and property and for the preservation of the public health, safety and welfare of the municipality and its inhabitants and, as may be necessary to carry into effect the powers and duties conferred and imposed by this subtitle, or by any other law; and,

WHEREAS, the Mayor and Borough Council of the Borough of North Plainfield, County of Somerset, State of New Jersey (the "Borough") have considered the decision of the United States Supreme Court in the case of *New York State Rifle & Pistol Association*, *Inc. v. Bruen*, which struck down the laws of the State of New Jersey, amongst other states, regarding the granting of and limits on permits for carrying of concealed weapons by individuals; and,

WHEREAS, the Mayor and Borough Council deem it necessary and appropriate to enact legislation to protect the safety and security of residents and citizens using public spaces, including schools and government buildings, pending further action, if any, by the Legislature of the State of New Jersey; and,

WHEREAS, the Borough wishes to amend, revise and supplement the Borough Code of the Borough of North Plainfield as it relates to Chapter II of the Borough Code specifically as to Administration, and provisions of Chapter III, Police Regulations, more particularly Section 3-3.2, "Possession of Firearms Prohibited."

NOW, THEREFORE, BE IT ORDAINED by the Borough Council of the Borough of North Plainfield, County of Somerset, State of New Jersey that the Borough Code of the Borough of North Plainfield, Chapter II, Administration, is hereby amended, revised and supplemented as to Section 2-3.2, currently titled "Meetings," and Chapter III, Police Regulations, more particularly Section 3-3.2, "Possession of Firearms Prohibited," as follows:

Deletions shown by strikethrough; additions shown by underline Borough Code § 2-3.2, Meetings, is hereby amended as follows: § 2-3.2, Meetings.

<u>a.</u> The biennial organization meeting in January shall be called to order by the Mayor; and after roll call and adoption of the rules of order, the first order of business shall be the election of President of the Council. Upon the election of the President of the Council he or she shall then preside at the Council meeting.

<u>b.</u> The regular meetings of the Council shall be held at such time and on such day as the Council shall, by resolution, designate in accordance with law, provided that when any such day falls upon a legal holiday or the day immediately preceding a primary or general election within the Borough, the meeting shall be held at the same hour on the next succeeding day that is not a legal holiday. The Council may provide by resolution in advance, for the scheduling of additional meetings, or the cancellation of any meetings. All meetings shall be held in the Municipal Building, unless the Council shall by resolution provide otherwise.

c. No person shall be permitted to carry any firearm, concealed or otherwise, in any public building during any public meeting of the Borough Council, its boards, bodies, commissions and/or agencies, except for any duly appointed law officer in the course of his or her official duties or carrying an authorized off-duty weapon.

Borough Code § 3-3.2, Possession of Firearms Prohibited, is hereby amended as follows:

§ 3-3.2, Possession of Firearms Prohibited.

<u>a.</u> It shall be unlawful for any person to possess or carry any shotgun, pistol, rifle, revolver, or any other contrivance prohibited by Subsection <u>3-3.1</u> hereof within the confines of the Borough when such shotgun, pistol, rifle, revolver or other contrivance is loaded and capable of being discharged.

b. No person shall be permitted to carry any firearm, concealed or otherwise, in any public building or adjacent public spaces at any time, including all public spaces owned, controlled and/or otherwise under the jurisdiction of the Borough of North Plainfield, and in any school building or adjacent public spaces, including any spaces owned, controlled or otherwise under the jurisdiction of the Board of Education of the Borough of North Plainfield except for any duly appointed law officer, or Special Law Enforcement Officer in the course of his or her official duties or carrying an authorized off-duty weapon by the school resource officer or Special Police officers. The head of school security may be permitted to carry a firearm if appointed and requested by the Superintendent of Schools and approved in writing by the Chief of Police.

NOW, THEREFORE, BE IT FURTHER ORDAINED that:

- 1. All ordinances or portions of ordinances that are inconsistent with this Ordinance shall be repealed as to their inconsistencies only.
- 2. If any provision or paragraph of this Ordinance shall be held invalid by any court of competent jurisdiction, the same shall not affect the other provisions or paragraphs of this Ordinance, except so far as the provision or paragraph so declared invalid shall be separable from the remainder or any portion thereof.

NOW, THEREFORE, BE IT FURTHER ORDAINED that this Ordinance shall take effect, after final passage, twenty (20) days following action or inaction by the Mayor as provided by law or an override of a mayoral veto by the Council, whichever is applicable and publication in accordance with law, unless a resolution is adopted, pursuant to N.J.S.A. 40:69A-181(b), declaring an emergency and providing that this Ordinance shall take effect at an earlier date.

AN**ORDINANCE** AMEND, TO REVISE AND **SUPPLEMENT** THE BOROUGH CODE OF THE **MORE BOROUGH OF NORTH** PLAINFIELD, **SPECIFICALLY** CHAPTER II, **ADMINISTRATION,** MORE PARTICULARLY SECTION 2-16, "DIVISION OF HEALTH, HOUSING AND PROPERTY," AND MORE **SPECIFICALLY CHAPTER** XI, **PROPERTY** MAINTENANCE, MORE PARTICULARLY SECTION 11-6, "ADMINISTRATIVE PROVISIONS."

WHEREAS, pursuant to *N.J.S.A.* 40:48-1 and *N.J.S.A.* 40:48-2, the governing body of a municipality may make, amend, repeal, and enforce such ordinances, regulations, rules and by-laws not contrary to the laws of this State and/or of the United States, as it may deem necessary and proper for the good of government, order, and protection of person and property and for the preservation of the public health, safety and welfare of the municipality and its inhabitants and, as may be necessary to carry into effect the powers and duties conferred and imposed by this subtitle, or by any other law; and,

WHEREAS, the Mayor and Borough Council of the Borough of North Plainfield, County of Somerset, State of New Jersey (the "Borough") have considered the process of providing trash removal throughout the Borough through the services of private providers and the Ordinances providing for the orderly, safe and healthy removal of trash throughout the Borough; and,

WHEREAS, the Mayor and Borough Council deem it necessary and appropriate to enact legislation to protect the health, safety and security of residents and citizens during trash removal and conduct trash removal in an orderly, safe and healthy manner; and,

WHEREAS, the Borough therefore wishes to amend, revise and supplement the Borough Code of the Borough of North Plainfield as it relates to Chapter II, Administration, more particularly Section 2-16, currently titled "Division of Health, Housing and Property;" and, as to Chapter XI, Property Maintenance, more specifically Section 11-6, "Administrative Provisions."

NOW, THEREFORE, BE IT ORDAINED by the Borough Council of the Borough of North Plainfield, County of Somerset, State of New Jersey that the Borough Code of the Borough of North Plainfield is hereby amended, revised and supplemented as to Chapter II, Administration, more particularly Section 2-16, currently titled "Division of Health, Housing and Property;" and, as to Chapter XI, Property Maintenance, more specifically Section 11-6, "Administrative Provisions," as follows:

Deletions shown by strikethrough; additions shown by underline

Borough Code § 2-16.1, Divisions Created, is hereby amended as follows:

(b) Division of Health. Within the Division, there shall be a Division of Health, which shall have and exercise all regulatory and appointive powers of a local Board of Health, though the Council shall still serve, where applicable, as the local Board of Health. The Division shall also:

1. Administer and enforce the local health ordinances; through the Public Officer, Health Officer or Code Enforcement Officer or their respective designees;

Borough Code § 2-16.1, Divisions Created, is hereby amended as follows:

- (c) Division of Housing. Within the Division there shall be a Division of Housing, which shall contain the following:
- 1. Office of Inspection. The Office of Inspection shall, by and through the Zoning Officer, Public Officer, Health Officer or Code Enforcement Officer or their respective designees, inspect to insure compliance with and enforce all land use ordinances and regulations, inspect to compliance with and enforce, to the extent permitted by law, any State municipal cooperative housing and/or building programs.

Borough Code § 11-6.1, Public Officer, is hereby amended as follows:

The person charged with the responsibility of enforcement of this Code shall also be known as the <u>Property Maintenance Officer</u>, Public Officer or Code Enforcement Officer or their respective designees. This Officer, under the direction of the Department of Administration, shall have authority as necessary in the interest of the public health, safety and general welfare, to implement the provisions of the Borough Code, including, but not limited to Borough Code 2-16.1, *et seq.*. Borough Code § 11-1.1, *et seq.* Borough Code § 14-1.1, *et seq.* and Borough Code § 26-1.1, *et seq.*

NOW, THEREFORE, BE IT FURTHER ORDAINED that:

- 1. All ordinances or portions of ordinances that are inconsistent with this Ordinance shall be repealed as to their inconsistencies only.
- 2. If any provision or paragraph of this Ordinance shall be held invalid by any court of competent jurisdiction, the same shall not affect the other provisions or paragraphs of this Ordinance, except so far as the provision or paragraph so declared invalid shall be separable from the remainder or any portion thereof.

AN ORDINANCE TO AMEND, REVISE AND SUPPLEMENT CHAPTER 2 OF THE BOROUGH CODE, ENTITLED "ADMINISTRATION", MOST NOTABLY ARTICLE I ENTITLED "ADMINISTRATIVE CODE," AND MORE SPECIFICALLY SECTION 2-4 ENTITLED "BOROUGH CLERK," TO AMEND, REVISE AND SUPPLEMENT SECTION 2-4.1 ENTITLED "APPOINTMENT."

WHEREAS, *N.J.S.A.* 40A:9-133 provides that in every municipality there shall be a Municipal Clerk to be appointed for a term of three (3) years; and,

WHEREAS, Borough Code § 2-4.1 of the Borough of North Plainfield provides that the Borough Council of the Borough of North Plainfield shall appoint a Borough Clerk; and,

WHEREAS, the Borough Council found that the appointment process should be reconciled with State laws regarding appointment to that position; and,

§ 2-4.1 Borough Clerk.

The Council shall appoint a Borough Clerk for the <u>a</u> term of three years, <u>who may</u> be reappointed to the position by vote of the Council after having served as Borough Clerk for not less than three consecutive years immediately prior to such reappointment and until the appointment and qualification of his successor. The Council shall appoint a Deputy Borough Clerk to serve for a like term term of three years, who may be reappointed after having served as Deputy Borough Clerk for not less than three consecutive years immediately prior to such reappointment.

RESOLUTION OF THE BOROUGH COUNCIL APPROVING PAYMENT NO. 4 (FINAL) TO CIFELLI & SON GENERAL CONSTRUCTION, INC. AND THE CLOSING OUT OF THE CONTRACT AND RELEASE OF RETAINAGE FOR THE 2020 NJDOT SUMMIT AVENUE ROAD IMPROVEMENTS.

WHEREAS, the Borough of North Plainfield previously awarded a contract for the 2020 NJDOT Summit Avenue Road Improvements (hereinafter referred to as the "Project") to Cifelli & Son General Construction, Inc. (hereinafter referred to as the "Contractor"); and,

WHEREAS, David Testa, P.E., C.M.E., C.P.W.M., of Grotto Engineering Associates, L.L.C., the Borough's Engineer for the Project, on behalf of the Borough, by letter dated August 12, 2022, a copy of which is on file in the Office of the Borough Clerk and made a part hereof, has reviewed the Contractor's submission for Payment No. 4 (Final) and Final Change Order No. 1 (Final); and,

WHEREAS, the original contract price was Three Hundred Eighty Three Thousand Two Hundred and Ninety Seven Dollars and Thirty Cents (\$383,297.30), which has been adjusted by Final Change Order No. 1 increasing the final contract amount by Three Hundred Fifty Three Dollars and Eighteen Cents (+\$353.18) for a final Contract Price of Three Hundred Eighty Three Thousand Six Hundred and Fifty Dollars and Forty Eight Cents (\$383,650.48); and,

WHEREAS, the Contractor has submitted the said Final Payment No. 4, adjusted by Final Change Order No. 1 in the total amount of Thirty Thousand Five Hundred and Fifty Eight Dollars and Twelve Cents (\$30,558.12), plus the release of any and all of the Contractor's retained funds held by the Borough for the Project; and,

WHEREAS, in accordance with the Contract, the Contractor has submitted a one (1) year Maintenance Bond in the amount of Thirty Eight Thousand Three Hundred and Sixty Five Dollars and Five Cents (\$38,365.05), with an effective date of July 1, 2022; and,

WHEREAS, Director of Law/Borough Attorney Eric M. Bernstein, Esq. and the offices of Eric M. Bernstein & Associates, L.L.C. have reviewed the Borough Engineer's and the Contractor's submissions and accept same based on the recommendations of the Borough Engineer.

NOW, THEREFORE, BE IT RESOLVED by the Borough Council of the Borough of North Plainfield, County of Somerset, State of New Jersey that the request for Partial Payment No. 4 (Final) and Change Order No. 1 (Final) and the Closeout of the 2020 NJ DOT Summit Avenue Road Improvement Project is approved with Cifelli & Son General Construction, Inc.,

CID Monthly Report

A Sample of Investigations & Arrests

On July 8, 2022 at 8:37am, a North Plainfield officer on routine patrol observed a 2006 Honda Odyssey traveling at a high rate of speed east on Greenbrook Road in the area of Rockview Terrace. The officer closed the distance and attempted to conduct a motor vehicle stop, but the driver refused to stop. After the officer terminated his efforts to stop the motor vehicle in the area of Somerset Street and Front Street in Plainfield, the vehicle continued south into Plainfield. A short time later at 9:03am, the Plainfield Police

notified Headquarters that the same vehicle was involved in a pedestrian struck and an officer involved shooting in the area of West Front Street and Central Avenue. North Plainfield Police units and detectives were dispatched to the area to assist with traffic control and securing the scene. Detectives are conducting a follow-up investigation which still continues.

On July 18, 2022 at 9:37am, patrol responded to the Asian Food Market on Route 22 for a report of an assault. The manager reported that and employee got into a physical altercation with a customer when the customer attempted to use a men's room that the employee was cleaning. According to the customer, when he tried to use the bathroom, the employee slammed the door in his face. When the customer attempted to open the door again the suspect poked him in the neck with a mop handle. Another brief altercation took place as the customer was seeking assistance. The employee left the scene prior to police arrival. The customer had no injuries and he was explained the complaint procedure.

On July 23, 2022 at 12:38pm, North Plainfield Police received word that a popup party was going to be held at an address on the East side of North Plainfield. The flyers, which have been posted on websites for preceding weeks, mentioned a party in the North Plainfield area, but withheld the address up until the date of the party. Tickets to the party were being sold and it appeared that alcohol was going to be served for a dollar amount through packages that were being offered. As soon as the initial flyers were observed, detectives began collaborating with the Somerset County Prosecutor's Office to prepare for charges and what evidence would have to be obtained to support those charges. When the detective received the alert that included the address, the detective was sent to the party undercover, purchased a ticket, and was served alcohol. A search warrant was then obtained and executed by the police department. Alcohol was being sold and served at the party and the party was shut down. Evidence, including cash and alcoholic beverages were seized, and the homeowner was charged with illegal sale of alcohol and maintaining a nuisance.
