1.2. Introduction

The Common Interface File (CIF) format has been developed as the standard for transfer of railway timetable data electronically from Network Rail's Integrated Train Planning System (ITPS) to other computer systems that require such information.

CIF is updated each night with train information that has been amended in ITPS and set for publication during the working day.

The structure used for presentation of each train schedule within the file has a consistent format, but the selection of schedules to be included in each user's extract can be varied by several selection filters including type of train, geographical area and timetable period. These selection filters are described in more detail in the relevant section of this specification.

Data is available for the current timetable period, and also for the next timetable period. Data for the next timetable period is normally available from approximately 12 weeks prior to the commencement date of the timetable.

CIF is administered by Capacity Planning Systems Support in Milton Keynes, part of Network Rail's Network Operations organisation. As the System Controller they are responsible for the maintenance of extract selection criteria for each user of the system and also for ensuring that extract files are correctly produced in accordance with appendix B and D as received from a user. The System Controller will also monitor daily or periodic 'housekeeping' processes and will follow the necessary investigative procedures for any errors within extract files. Procedures associated primarily with the System Controller are not detailed as part of this specification.

1.3. Definition of terms

- CIF: Common Interface File.
 - File format used for transfer of timetable data from planning systems (ITPS) to "downstream" operational and information systems. Content defined in detail in this document.
- JCL file
 - Meta-data file generated by Metastorm & transmitted to the ATOS mainframe, containing details of onward routing for the file.
- ITPS: Integrated Train Planning System
 - System and interfaces used by Network Rail's Capacity Planning department to hold, validate, and distribute timetable data.
 - NB: "TPS" refers to the central planning system; "ITPS" refers to the system plus interfaces (including Metastorm components).
- TSDB
 - Obsolete database holding timetable data prior to introduction of ITPS.
- Metastorm
 - Workflow system handling among other things the scheduling of CIF production and the transmission of CIF files to the ATOS mainframe for onward distribution.
- ATOS mainframe system
 - Handles onward transmission of CIF files via FTF or FTP.
- FTF: File to File
 - o ATOS proprietary file transfer mechanism
 - Not to be confused with industry-standard FTP.
- LTP: Long Term Plan
 - "Permanent" schedules prepared in advance for a timetable period. Initially issued 26 weeks prior to timetable period commencement but subject to later variation.
- STP: Short Term Plan
 - Amendments, additions and cancellations against the long term plan. Initially issued 12 weeks prior to relevant week, but subject to later variation.
- Train
 - For the purpose of this document, the term "train" refers to a set of schedules with a common UID.
- Schedule
 - For the purpose of this document, the term "schedule" refers to a set of data for a train on specified dates, including calling pattern, times, and other related information.
- Association
 - An association is an interaction between two trains which use some or all of the same physical rolling stock. This may be:
 - Next working: the main train terminates, and the other train originates at the location
 - Split: the main train continues, and the other train originates at the location
 - Join: the main train continues, and the other train terminates at the location

- Change en Route
 - Where some of the basic details of a train change partway through its journey, this is referred to as a change en route. Values that might change include service code (e.g.: for billing purposes when moving between infrastructure with different maintainers) and timing load data (e.g.: where a monitoring train goes from transiting to recording states). See CR record definition for a comprehensive list.
- TIPLOC: Timing point location
 - Schedules refer to locations in terms of TIPLOCs; these are theoretical constructs intended to simplify planning and not precise physical definitions. They are maintained by Capacity Planning.

2. END USERS OF THE COMMON INTERFACE FILE

2.1. General Information

- The end users of the Common Interface File (CIF) system are computer systems requiring train data from the Network Rail Integrated Train Planning System (ITPS) in electronic format. The CIF data is generated from ITPS, compiled using Metastorm, and then distributed to a mainframe (maintained by ATOS), for onward distribution to end users.
- There will be no direct access of CIF by end users.
- CIF users receive their files by one of three mechanisms: collection from Network Rail server (internal only); FTF transmission (usually older systems) and FTP transmission. (TOP2 and CTRL files are exceptions to this rule).

2.2. Local Users

- Files will be held at <u>\\gshv01ap05\AppsServer\mainframe\Delivery</u>
- Use FTF site ID R321 to request this service.

2.3. Remote Users (FTF and FTP)

- Each remote user of the CIF will need a communications connection that allows access to transfer data from the ATOS mainframe. This may be an FTF or an FTP connection; if you are configuring a new user this will usually be FTP.
- For an FTF site ID you must apply to the CIF controller, who will arrange setup with ATOS.
- For an FTP connection you must supply IP address, username & password to the CIF controller.
- The communication connection between the mainframe and the end user is managed by ATOS.

2.4. Ordering of Extract Files

For an initial extract both the User Description form (Appendix B) and Extract Request form (Appendix D) must be completed and sent to Network Rail's Planning Systems Support Team via email (<u>pss-team@networkrail.co.uk</u>). The date the extract is required and (where applicable) the date the User can be made dormant should be clearly indicated.

An Appendix B form is required for all amendments made to a CIF profile, and Appendix D is required for all CIF requests. (Requests will not be processed until a correct Appendix B / Appendix D is received.)

Notes on the completion of the User Description form can be found in Appendix C.

CIF requests detailing changes to user profiles or requests for extracts must be submitted to <u>pss-team@networkrail.co.uk</u> in the form of an Appendix B / Appendix D. In general two working days should be allowed for processing, but the team will endeavour to process requests received prior to 12:00 for the same working day.

Extracts can be produced on a regular basis at regular intervals upon request. The system controller has the ability to schedule regular full extracts to be produced.

It is preferable that any CIF requests are registered as soon as possible. This allows time to resolve any queries that may arise.

2.6 Deleted and Amended Users

- If the deletion of a user is requested, the System Controller will delete the user profile record and no more extracts will be produced.
- A facility also exists for the System Controller to make a user "dormant"; no further extracts will take place until the user is reactivated and a full extract requested. This full extract will be provided within 48 hours.
- It is also possible to amend the selection criteria applicable to a user profile. Changes made will take effect from the next extract. Details are given in Section 5 'Determining Composition of Extracts'.

3. EXTRACT FILE

3.1. File Contents

3.1.1. Schedules

• The file will contain a set of train schedules of interest to a user. A train schedule is an image of a train where all the train's details are constant for the dates the schedule applies. Train schedule details will be the same as those held in ITPS, with the exception of certain activity code alterations. Activity codes in the CIF file will be as specified in Appendix A.

NB: 'indefinite' end dates of '999999' are no longer permissible.

- Only schedules for totally valid trains which have been successfully published will be generated in the extract file. Should a valid train be edited in ITPS and in consequence become invalid, the CIF user will be left with the last valid schedule(s) for the train. Once the train is made valid and republished, the new set of schedules will become available for the user.
- As extract files will specify how a user's train data has changed, the end user must be able to identify the schedules referred to by the extract file. A train schedule can be uniquely identified by UID & Start-date for non-overlay users and by UID, Start-date & Overlay indicator for overlay users. These are the identifiers which both CIF & the End User must use.
- Deletions will not be raised for schedules that have become historic.
- Amendments may be received for historic schedules where alterations are made after the schedule has started running but before it has finished.

3.1.2. Associations

- The file can also contain train association records if requested. These document the link between a pair of trains. Associations will be passed to the user independently of train schedules. CIF will document when an association occurs by holding the dates for which the association applies, not the schedules to which it applies. The user will have to establish the schedules involved in the association.
- Associations between two trains do not necessarily occur on exactly the same set of dates as
 far as the train schedule dates are concerned. This situation arises either: (a) when one train
 runs over midnight and the other does not, and the first train associates with the second after
 midnight; or (b) where a train terminating late one day is associated with a train which runs early
 the following day.
- A runs 29/05/15 21/09/15 FSX, B runs 30/05/15 22/09/15 MSX, A & B are associated with each other. The Association applies from 29/05/15 21/09/15 FSX.
- The association dates refer to those of the Base UID, not necessarily the date on which the association takes place. Where the dates of the associated train schedules will either be one day ahead or behind those of the Base UID schedules this is indicated by Association-type. In this case Association-type would be set to 'N'.
- In the case of Join (coupling) & Divide (splitting) Associations, the Base UID will always be the 'through' train.
 For Previous/Next Associations, the Base UID will be the train that has a 'next' working (i.e. the Base UID will always be the earlier train in chronological order).
- The User system will be told of an association if it is interested in any of the schedules for either of the trains involved. Note that, for a geographic CIF user, an Association for a train running through the specified geographic area may take place at a location not specified for that area. In this case the associated train will only be available to the user if this second train also has other locations in common with the specified geographic area.
- If the User receives an amended schedule for a train, if the new schedule invalidates one or more existing associations, deletion(s) will be generated for the association(s) invalidated by the update in train schedules.

3.1.3 TIPLOC Codes

• Details of TIPLOC location codes can be included in the file if required, with the option provided to receive updates on a regular basis (normally this will take place on week-nights following the process to update the ITPS infrastructure).

3.2. File Generation

- Any active End User of CIF will automatically have an update file generated every night (including weekends). If a full extract is required this will be produced weekly. Files will be generated after the ITPS publication run is complete.
- As the user is sent a series of updates it is imperative that the extract files are processed in the order generated. The header record contains the date & time of the file's creation, and a unique reference of the current file and of the last file generated for the User. The User should compare the 'Last-file-ref' with the 'Curr-file-ref' of the last CIF Extract file processed. If the two are not the same, no further processing should be carried out on that file, as it is not being processed in the correct order.
- For remote users the files will be queued for transmission in the sequence in which they are received at the mainframe from ITPS. In the case of a transmission failure, however, care must be taken to ensure the files are still processed in the original order.
- Both mainframe and remote users' files will be automatically deleted from the mainframe 26 days after generation (even if remote users' files have not been successfully transmitted). If it is required to retain the files on the mainframe for a longer period than this they should be copied or renamed to prevent deletion. (Users should be aware that the CIF file name only remains unique for a maximum of 26 extract files. It is recommended that users implement a mechanism to delete or rename files.)

3.3. File Format

- The file is sequential containing fixed length 80 character records. It will contain different record types which can be identified by the 'record identity', the first two bytes of a record.
- The sequence of records within the file is significant. The following sequence laws will apply [the record identity is given in brackets ()]:
 - i) Header record (HD)
 - ii) TIPLOC location change records in the following order:
 - 1) TIPLOC Insert records (TI)
 - 2) TIPLOC Amend records (TA)
 - 3) TIPLOC Delete records (TD)
 - iii) All association records in the following sequence (AA)
 - 1) Association Start Date
 - 2) UID Number of Main Train
 - 3) Transaction Type in the order DELETE>NEW>REPLACE
 - iv) All train schedules in the following sequence:
 - 1) Schedule Start Date
 - 2) UID Number of Train
 - 3) Transaction Type in the order DELETE>NEW>REPLACE (see note below)

(N.B. for overlay users, Permanent schedules will precede Cancellations or Overlays where they are for the same Start-date/UID)

A train schedule comprises a set of records, output in the following order:-

- 1) a basic schedule record (BS)
- 2) a basic schedule extra details record (BX)
- 3) train specific note records, if present (TN)
- 4) an origin location record (LO)
- 5) all intermediate location records (LI) in journey sequence, preceded by a Change en Route, if present, for the location (CR)
- 6) terminating location record (LT)
- 7) location specific note records (LN); these may follow any LO, LI or LT records
- v) Trailer record (ZZ)
- Where a train schedule deletion (transaction type D) or cancellation (STP overlay indicator C) is raised, only a basic schedule (record identity 'BS') will be output, with only the identifier fields populated (including End Date and Days Run for new STP cancellations). Otherwise, the schedule will consist of at least record types BS, BX, LO and LT.
- Note that it is possible to receive an "empty" file, consisting of a header (HD) and a trailer (ZZ) only.
- Note that TN and LN records are not currently in use.
- Note that CR records may apply to any LI record, regardless of whether or not the location is a stopping point.

3.4. Further File Details

3.4.1. Selection of Schedules

- If a train is updated in ITPS and successfully published, new or amended schedules will be
 passed to CIF. Any differences from what was held before will be passed on to interested
 users. If only some schedules for a UID are affected, only updates for those will be passed to a
 user; hence the user may not receive a full set of schedules for an amended UID and must
 retain any existing ones not replaced/deleted. The same logic applies to associations; also new
 schedules may be issued for a UID without new association records if the latter are unchanged,
 and vice versa.
- Because of the complexities of STP, sometimes users may receive a <u>delete</u> for a UID/start date/STP indicator, followed by a <u>new</u> schedule for the same UID/start date/STP indicator.
- A user may sometimes receive an LTP schedule which does not run on any date in the time window; inclusion of LTP schedules in CIF is based on their original ('nominal') start and end dates and not their actual running dates.

3.4.2. UID Validity

• Only trains where the UID is valid in ITPS for all timetables will be passed to CIF (and hence to CIF users), regardless of the current CIF time window.

3.4.3. Associations

- If either of a pair of associated trains is cancelled on an STP basis for some days/dates, this will be interpreted as also cancelling the association. STP and overlay users will receive association data reflecting this. For STP users, the association dates will exclude the cancellation period; for overlay users, a cancellation record for the association will be produced for the appropriate days/dates.
- Only valid associations will be passed to users; these are associations where both trains are valid and the association is valid.
- It is possible for an association to be amended or cancelled for STP purposes without any amendment to the relevant train schedules (i.e. the relationships between trains are changed, but not the trains themselves). Also, it is possible to have an STP association defined, where no permanent association exists.
- It is possible for a train to have more than one association of any type (or a combination of types) at a single location.

3.4.4. Repeated Locations

• A specific location may occur on each schedule up to nine times. These are distinguished by unique suffix values (either 'blank' or in the range 2-9 inclusive) following the TIPLOC in the 'LOCATION' field of the LO, LI or LT records. If present, the suffix value will always appear as the eighth character, even if the TIPLOC has less than seven characters.

3.4.5. 2-digit years

- Where 2-digit year codes are used they should be interpreted as follows:
 - o 00-59: 20XX
 - o 60-99: 19XX

3.4.6. Daylight savings

• There is no mechanism in the CIF process to make adjustments for daylight savings time. The running of services affected by clock change is detailed in the relevant Weekly Operating Notices.

4. RECORD LAYOUTS

This section contains layout descriptions for all the CIF record types. Each record is 80 characters long, although in most cases not all of the record is defined.

5. USER DETAILS AND DETERMINING COMPOSITION OF EXTRACTS

5.1. General

- User details, including selection criteria, will be set up and maintained on behalf of the user by the CIF System Controller.
- Changes to a CIF profile will only be made upon receipt of a completed Appendix B/Appendix D. Changes can only be made between the hours of 12:00 16:00.
- The user requiring the extract can effectively specify the data that will be received by drawing up selection criteria for their system. The selection criteria identified in the Appendix B/Appendix D form will be used to determine what data is to be extracted for a user.
- Extracts for new and re-activated users, full extracts for active users, and amendments to extract criteria will be made within two working days; see section 2.4 for further detail.
- The following sections are presented in the order they appear on the User Description form (Appendix B) and on the input screen used by the CIF System Controller.

5.2. System Name/User Description

- An identification of the system and/or purpose for which the data is being supplied,
 a.g. (CIS Anotown', 'Traffic Analysis System', etc., The upper must also supply details of
- e.g. 'CIS Anytown', 'Traffic Analysis System', etc. The user must also supply details of a contact person, together with address, 'phone number, e-mail, etc. This should be the preferred point of contact in case of problems occurring in the provision of the CIF extract file(s) or other current production issues. A generic/central contact address is preferred for continuity.

5.3. FTF Site ID or FTP IP address & logon details

- For FTF transfer, supply site ID (or apply to CIF administrator for new FTF ID)
- For FTP transfer, supply IP address & logon details.
- For local (NR internal) file, leave blank.

5.4. STP

- The user can indicate if Short Term Plan train data is required in the extract or not. If it is not required, schedules will be generated which will not reflect any STP changes made to trains.
- If STP data is required, the user can choose to be either:

(a) an STP user where the schedules provided for the user will reflect STP changes BUT the STP data will not be identified as such to the user.

(b) an Overlay user, where STP data will be identified as such and passed to the user as an overlay of the non-STP or permanent data (i.e. the Permanent data is retained in addition to the Overlay, but the Overlay is assumed to supersede the Permanent position)

N.B. For geographic users, it will be possible to get STP overlays (containing information of interest to the user) for which there is no corresponding permanent schedule. For example, a geographic user based at Edinburgh might be in this position when a Newcastle - London train is amended to start back at Edinburgh on a Bank Holiday.

Conversely, geographic users will also receive overlays that do NOT contain data of interest, where the overlay relates to a permanent schedule that IS of interest.

• If the STP selection indicator is changed the extract will be provided within 48hrs.

5.5. Reservations Only

• Users can specify if they wish to receive only data relevant to trains that have seat or bicycle reservation facilities. These trains are defined as those schedules with a positive value in the Reservations field of a BS or CR record.

5.6. Associations

• Users can specify if they wish to receive associations or not. It is NOT possible to amend this parameter once a user has been set up. The only option open is to delete the user and create a new one with the required parameters.

Implications:

- a) Users may receive association information concerning a pair of trains, one of which they have no schedules for. This will result from their selection criteria, which may result in the extraction of one train but exclude the extraction of the train to which the first train is associated.
- b) A schedule for train A may be associated with one, more than one, a part of one or a combination of part and whole schedules on train B. Depending on the user's time window, the user may not have all the schedules for the trains, to cover the association dates. The user will, however, have all the data required before it becomes current.

e.g. The user will receive the first set of association dates, schedules A1, B1 & B2 but not A2. The association cannot be fully resolved until the time window moves to include A2.



- c) Where an association only applies for some of the days/dates for which a train runs, separate schedule(s) for the train are not issued for the period(s) that the association applies, if all the other data is constant.
- d) Note that the availability of association data in CIF is dependent on the presence of associations in ITPS, which varies on a location-by-location basis; for specific information please contact the relevant planning team.

5.7. Output on CD

CDs will no longer be supplied under normal circumstances. Exceptions may be requested from the CIF controller.

5.8. European Data

- It is not currently possible to receive information on Continental European schedules i.e., services wholly outside the UK via CIF.
- Where it is required to show Continental locations on through international services i.e., crossborder traffic - then standard alphanumeric TIPLOC codes will be created for these locations. These services will be considered for inclusion in the CIF on the same criteria as domestic services.

5.9. Train Status Values

- If no train status is specified then trains of all Statuses will be extracted (subject to other extraction criteria).
- Up to 10 different values of train status can be specified. Only trains of this status will be passed to the user. Train status values are:- P, F, T, B, S, 1, 2, 3, 4, 5 (see Appendix A).
- The trains passed to the user may be further restricted by other criteria.
- The first extract after the change is made will be an update that includes all relevant schedules for trains with the new status values. Schedule deletions will be issued for trains previously extracted, but with status values no longer specified.

5.10. Train Category Values

- If no Train Category selections are specified then trains of all Categories will be extracted (subject to other extraction criteria).
- Up to 50 values of Train Category can be specified, selected from the list defined in Appendix A.
- If Ships are required then Category 'SS' must be specified in addition to the relevant Status.
- The first extract after the change is made will be an update that includes all relevant schedules for trains with the new category values. Schedule deletions will be issued for trains previously extracted, but with category values no longer specified.

5.11. Time Window.

The User time window can be specified either as a number of days from the current date or as a period with a specific start and end date.

Note that once a profile has been created, it cannot be changed from time window to fixed dates or vice-versa.

Rolling time window

- For a user time window specified as a number of days, only schedules which start on or before the time limit for the user will be passed on. The user's time limit is equal to the Nth day after the date on which the extract is generated, where N is the number of days specified for the time window; e.g. an extract generated on 03/05/09 for a user with a 7 day time window will include any schedules starting on or before 10/05/09. Each day, the user will therefore get schedules that apply during a time window one day further forward than the previous day.
- Subject to the previous paragraph, if a time window is extended by the CIF System Controller, schedules applicable to the new time window will be contained in the first extract.
- If a time window is reduced, the system will continue to issue schedules for the original time window, reducing by one day every day, until the revised value held on the user profile is achieved. This will ensure that the user can maintain the integrity of data previously extracted within the original time window.

Fixed Start and End Date

- For a user time window specified with a fixed start and end date, only schedules which apply (at least partially) between those dates will be passed on. The dates can be periodically amended by request to the CIF System Controller as required. The start date can be set for the current or any future date.
- Please note that after an end date has been set for a User Id, then this date can not be brought forward.

5.12. Location

- Up to 150 different TIPLOCs can be specified to restrict the data provided on a geographic basis. Only trains that have at least one LO/LI/LT record for any of the nominated TIPLOCs will be included in the user extract file.
- After changing the list of locations, the next extract will be an update that includes all relevant schedules for trains that have events at the new locations. Schedule deletions will be issued for trains previously extracted, but with no events on the new list of locations.
- If no TIPLOCs are specified, the user will be 'non-geographic', and receive all train schedules (subject to the other selection criteria).

5.13. TIPLOC Extract

- Users can specify whether TIPLOC location information is to be included in the file.
- The initial extract will contain details of all codes currently on the TIPLOC file (i.e. a full extract). Updates will then be included (normally on a weekly basis) of any amendments, additions or deletions.
- The User profile can be amended so that TIPLOC updates are no longer received, or to provide a new full extract, without affecting the provision of train schedule and association data.
- Once a user has been amended to receive no TIPLOC updates the next request for location information must again be for a complete full extract.

6. SYSTEM LIMITS

Various limits have been set on the data that can be extracted for a UID from ITPS to CIF; most of these limits should not present any practical constraints on the user. These limits are due to the capabilities of key downstream systems;

- The maximum number of events on a dated schedule (start date + UID) is 150. The maximum number of events on a UID, regardless of date, is 5000.
- The maximum number of schedules that can be created on CIF for a UID is:

200 permanent and 200 STP

This could theoretically lead to more than 400 schedules in total for an STP user due to the interaction of permanent and STP dates.

- The number of associations is limited to 200 permanent and 200 STP associations for a pair of trains with the same diagram type/location.
- The maximum number of changes-en-route for a schedule is 50.
- Within a permanent schedule, STP data must not cause more than 64 different schedules for an STP user. STP trains that have associations must not have more than 20 sets of dates.
- If any of the system limits are exceeded, the train will be rejected by CIF and a report generated for the CIF System Controller.

In addition, certain other error conditions can be detected on trains valid on ITPS. These will result in error messages to the CIF System Controller and, in some cases, the train being rejected by CIF.

Appendix A: LISTS OF VALID VALUES

Note that these lists are not static; values may be added, amended or deleted as required. The existence of values in the lists does not imply that they are necessarily valid in combination with each other or other fields.

Extract Requirements

FTF site ID or FTP IP address & logon details: For FTF transfer, supply site ID (or apply to CIF administrator for new FTF ID). For FTP transfer, supply IP address & logon details. For local (NR internal) file, leave blank.

STP Data Required: Values Yes, No or Overlay (Y/N/O). To indicate whether Short Term Plan (i.e. Special Traffic) train data is required. The Overlay option will provide STP data in addition to the base WTT timetable information. Highlight value required. N.B. N.B. If all Train Categories are required it is not necessary to circle any values. The extract will then be based on the Train Status values requested and will include all trains with those values whatever the Train Category.

Time Window: Enter either a number of days or start date and end date.

If number of days is specified only schedules that start on or before the user's time limit will be included in the extract file.
