**Here's an example of what to say or write to your State Representative and State Senator:**

"I am concerned about the ever growing sums of money and the potential corrupting influence it has in our elections. I believe that bills **H-933** and **S-53** would clear the way for legislation that would begin to address this critical issue. These two Legislative Amendment proposals are now scheduled for consideration at the MA State Constitutional Convention on **February 3, 2016**. Since they will make it "to the floor" for a vote only if there is mass support from citizens, I am showing my support early enough to give you time to speak with your colleagues and encourage them to support the bills, too. I am asking you to do what is necessary to build momentum and see that **H-933** and **S-53** move forward towards a favorable outcome this February. "
