TAT (Steve Starcevich)

I attended the Silverton Sustainability Coalition monthly meeting to describe our Car Free event and answer questions about logistics and participation. They are interested in putting on the same event in their town this spring.

Coalition Annual Meeting (Marge Stevens)

We discussed the coalition's annual meeting and considered ideas about how to deliver food to online attendees. Ideas included using a bicycle fleet or the transit system for deliveries of co-op snack boxes, could be used as an opportunity to ask for a donation/fundraising, make it a car free event. Well over 100 people are expected to attend February 3, 2021 at Noon.

Oregon Cascades West Council of Governments (Steve Dobrinich)

Corvallis Area Metropolitan Planning Organization (CAMPO) launched their Bicycle and Pedestrian Count Program. Automated equipment is up and running on new Marys River/Crystal Lake multi-use path in South Corvallis. CAMPO won't be writing reports on data from every count location, but data will be available and shared with board. Count data will used to better understand mobility, to create interactive maps, and long-term analysis by CAMPO. Corvallis Economic Development Office was awarded an electric mobility grant from Pacific Power to buy electric bikes. Jerry Sorte, from Corvallis EDO, wants to allow more business to put tents up for the colder season.

Vision Zero South Town (Jay Thatcher)

ODOT is seeking public participation on 3rd Avenue/OR99SW South Corvallis Facility Plan. Road Safety Audit will be attended by Steve Dobrinich, as a participant, and Jay Thatcher, as part of a stakeholder advisory group. Citizens can comment on the map on 3rd, citizens have been interviewed by consulting company representing ODOT. This part of South Corvallis area plan/zoning review process. Corvallis Bicycle Collective (Sylvan Hoover)

CBC reopened after instituting pandemic safety precautions. Ventilation was improved, in-shop hand-washing station was added, and spacing was increased between work stations. Open Streets Corvallis in 2021 isn't off the table. Organizational structure of Open Streets Corvallis is still under discussion.
