## Role & Responsibilities.

- Establish the Monitoring and Evaluation section in Malteser Peshawar project office;
- Ensure that two supported BHUs in Peshawar project regularly submit weekly and monthly reports in time on Malteser standard formats;
- Develop and update the project summary sheet and if required should revise it in consultation with the project manager and health program coordinator;
- Work closely with the other project sections in project and coordinate/harmonize their data collection and database;
- Ensure the promotion of a learning cycle within the project and facilitate feedback to the concerned project sections:
