Meeting Summary

1. QUORUM

The Chair determined that quorum was met and called the meeting to order.

2. WELCOME AND INTRODUCTIONS

Jurisdiction representatives and guests introduced themselves.

3. REVIEW OF THE APRIL 7, 2022 MEETING SUMMARY

Rimiga Viskanta, City of Solana Beach motioned to approve the April 7, 2022 Meeting Summary. Leslie Webb-Blanco, City of Vista seconded. Motion carried to approve the Meeting Summary.

4. PUBLIC COMMENTS AND COMMUNICATIONS

Mallika Sen, Solana Center for Environmental Innovation: The Solana Center continues providing SB 1383 assistance for several jurisdictions including tier identification and capacity planning. In addition, Solana Center is conducting organic recycling outreach in Encinitas and has met with over 70 businesses. Most entities have been receptive to the new program and some

noted concerns regarding cost and space. The Solana Center in partnership with the County held a commercial food waste prevention webinar on May 4. For a full list of upcoming events visit solanacenter.org/free-compost-workshops.

Steve Morris, I Love a Clean San Diego: A list of upcoming events was shared including Commercial Kitchen Food Waste Reduction Webinar (5/11), Used Oil Filter Exchange Events with participating AutoZone stores in the unincorporated areas (5/14) and the Conscious Closets webinar (5/21). 5. CHAIRPERSON'S REPORT

Eric Wolff, County of San Diego: The County has an open recruitment for a [Recycling Specialist II](#). In February-March 2022 several jurisdictions and organizations participated in a collaborative project to compile a list of commonly used waste, recycling, and organic waste recycling Spanish terms. This resource has been added to the County's social media playbook available [here](#). The County is undertaking a recycling capacity study that is anticipated to be presented to the Board of Supervisors in Spring of next year.

6. PRESENTATION

Leo Beckerman, Zero Foodprint: [Zero Foodprint](#) (ZFP) is a nonprofit organization that works to scale compost use and regenerative agriculture. ZFP is currently underway with carbon farming and compost application projects and has awarded over \$900,000 to 50 carbon farming projects on 5,000 acres since January 2020. The program works by collecting funds from restaurants, businesses, individuals, and philanthropists to restore carbon and distributes grants to farmer applicants for healthy soil projects. ZFP also maintains a compost connector program where ZFP maintains a database of shovel ready compost projects including farmer preferences and details. Regarding SB 1383 procurement requirements, ZFP's program can geolocate projects and facilities for cost sharing to optimize budgets and climate and provide complete reporting and recordkeeping. 7. CALRECYCLE UPDATE

Roberta Goldenpenny, CalRecycle: Roberta reported on the following:

- LAMD is scheduling conference calls with jurisdictions to identify SB 1383 assistance needs.
- Upcoming webinars and meetings include: EPA Region 9 National Recycling Grant Funding Overview and Feedback Session (5/11); Circular Economy Symposium (5/17); Electronic Annual Report Walkthroughs (multiple days in June); Overview of the 2021 California Waste Tire Market Report Workshop (6/22); CalRecycle public meeting (5/17).
- Previous webinar recordings have been posted including the Compost Use Best Management Practices Webinar and the SB 1383 RDRS Reporting Requirements Starting in 2022 webinar.
- Co-Digestion Grant applications are due May 19th. The Q&A page for the grant has been updated.

8. CPSC UPDATE

Doug Kobold, California Produce Stewardship Council – A legislative update on bills sponsored by CPSC was shared:

- [AB 2440](#), Battery and Battery-Embedded Product Recycling and Fire Risk Reduction Act of 2022 – Last amended 4/27/22. In Assembly Approps.
- [SB 1215](#), Battery and Battery-Embedded Product Recycling and Fire Risk Reduction Act of 2022 – Amended 4/21/22. In Senate Approps.
- [SB 1256](#), Waste management: disposable propane cylinders – Passed out of Senate Judiciary on 4/19.

A legislative update on the following bills was also shared:

- [SB 45](#), Short-lived climate pollutants: organic waste reduction goals: local jurisdiction assistance. In Assembly pending referral.
- [SB 54](#), Plastic Pollution Producer Responsibility Act. In Assembly pending referral.
- [AB 1690](#), Tobacco products: single-use electronic cigarettes. Passed out of Assembly Judiciary on 4/19, now on 3rd reading (CPSC support)
- [AB 1894](#), Integrated cannabis vaporizer: packaging, labeling, advertisement, and marketing. In Assembly Approps.
- [AB 2638](#), School facilities: drinking water: water bottle filling stations. In Assembly Approps on Consent (CPSC support)
- [AB 2886](#), Recycling: electric vehicle lithium-ion batteries – Dead.
- [SB 1232](#), Solid waste: products: labeling: biodegradability. Hearing on 4/18 in Senate Approps.

An update on clean trucks regulation regarding CARB, CPUC, and SB 1383 for zero emission vehicles, renewable natural gas and procurement was also shared.

13. SUBCOMMITTEES' REPORT

a. Household Hazardous Waste – No report.

b. Organics – The April meeting included a presentation on the Regional Decarbonization Framework (RDF). The RDF is a partnership between the County, UC San Diego School of Global Policy and Strategy and the University of San Diego Energy Policy Initiatives Center and Inclusive Economics to move the region toward zero-carbon emissions. Interest in a future TAC presentation on the areas of overlap with the waste and recycling sector, including sustainable land management strategies and use of recovered organic

waste products. Members of the committee also presented opportunities for compost and mulch use at the American Society of Landscape Architects meeting. Interest to collaborate with local community colleges on a design competition for compost bmp's.

- c. **Edible Food Recovery** – Stephanie Ewalt, with the County of San Diego will be retiring from the County shortly and Caitlin Lelles, Program Coordinator will be leading the EFR meetings moving forward. The next meeting is scheduled for May 9 and a new meeting outlook will be sent out afterwards.

14. ROUNDTABLE

Eric Wolff, County of San Diego: Eric brought up for discussion with TAC members holding a July TAC meeting. With no opposition noted, TAC will be held in July.

Ashlee Stratakis, City of Encinitas: The City will be holding a free paper shredding, mulch giveaway and e-waste collection event at City Hall on May 7. The City and Healthy Day Partners are hosting a few workshops on growing food and food waste (5/14, 5/21, 5/28). Save the date for the Zero Waste Fair at the EUSD Farm Lab in Encinitas with I Love a Clean San Diego on June 25. The City also has an RFP posted for a consultant for SB 1383 implementation. Proposals are due 5/11. Ashlee also asked the group if any jurisdictions had policies on donating unwanted equipment and furniture.

Alyssa Wagner, City of Carlsbad: AVECITA Jones is running for a position as a CRRA Board Member and encouraged any interested CRRA members to submit their ballot.

Annika Andersen, City of Oceanside: The City will be holding 3 upcoming used oil filter exchange events in May. The City is also continuing SB 1383 implementation with commercial businesses and the upcoming rollout to multi-family complexes.

Manuel Medrano, City of Chula Vista: Interest in a SB 1383 code enforcement training and asked if other jurisdictions were interested in participating. They are looking for a venue to seat 150 people. Earth Month included numerous events across the region that were scheduled close together. Interest in coordinating future events amongst jurisdictions.

AVECITA Jones, City of Carlsbad: The City is rolling out organics recycling to City facilities and asked the group if other jurisdictions provided their city facilities with internal bins. The City will also be providing a presentation on their food recovery program at Waste Expo.

Heather Heckman, City of Santee: Santee has a residential community dump day and shred event on May 14.

Sara Marshall, City of El Cajon: City of El Cajon has a community shred, mulch, and e-waste collection day on May 14.
